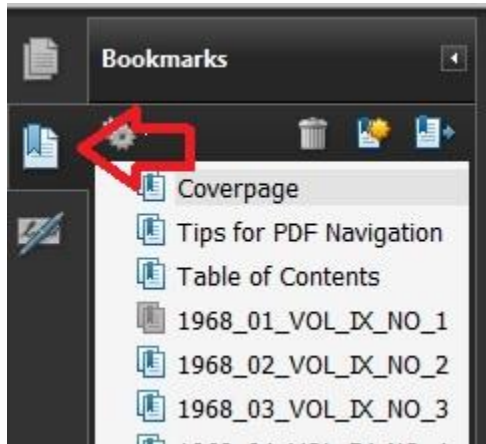

If your bookmark pane is not open, navigate to **View, Navigation Panels, Bookmarks** to open it:

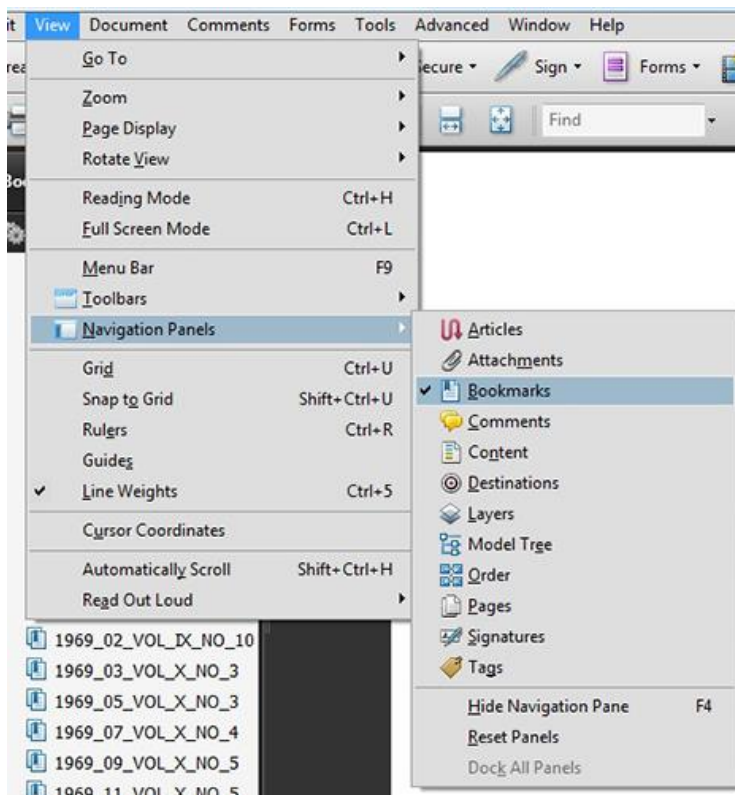

PRESIDENT'S MESSAGE

Dear Members,

Most of you want to know what happened in Orlando. It is my hope that the following detailed explanation will clarify events of the AGM for all members. Too much has been circulated that is misleading, motives ascribed which are inaccurate and letters containing half-truths and misperceptions which damage the good name of our Society and your Board of Directors abound. This is unfortunate and I urge you to take the time to read the minutes in this Newsletter to better understand the situation and to bear with us while we attempt to sort things out.

In September, just prior to the AGM, it came to the attention of the Board in a roundabout way that some members had consulted lawyers to scrutinize our bylaws and the Illinois General Not for Profit Corporation Act under which we are incorporated. The resulting legal opinions WERE NOT AND HAVE NOT been officially shared with the duly elected officers and directors of the Society. When a copy of one candidate's letter asking for proxies and including a copy of a letter from the candidate's attorney came into our hands we immediately hired an attorney to ascertain if, indeed, proxy voting is legal in our Society. On September 24th, we received a legal opinion from our attorney stating that proxy voting is allowable under our current bylaws and we set in motion notification of all members considered eligible to vote that this was the case and planned to hold the election at the AGM using a combination of in-person and proxy voting.

To help you understand WHY proxy voting is currently allowed, please read the excerpts from the Illinois Law and our by-laws printed below:

107.50. Proxies. A member entitled to vote may vote in person or, unless the articles of incorporation or the bylaws otherwise provide, by proxy executed in writing by the member or by that member's duly authorized attorney-in-fact.

Article IV, (e) Voting. In all matters governed by the vote of the membership, each membership which has been on the rolls of the Society prior to January 1 of the current year, and is in good standing, shall be entitled to one vote. Partnerships or corporations when elected to membership shall be required to notify the Secretary in writing, designating a member of the partnership or an officer of the corporation who shall represent such partnership or corporation and be entitled to cast its vote at any meeting of the members.

(f) Action at Meeting. When a quorum is present, a majority of those present or represented and voting on a matter, except where a larger vote is required by law, the Articles of Organization or these By-Laws, shall decide any matter to be voted on by the members. Any election by the members shall be determined by a plurality of the votes cast by the members entitled to vote at the election. No ballots shall be required for such election unless requested by a member present or represented at the meeting and entitled to vote in the election.

Please note that the only REPRESENTATIVES mentioned in our bylaws are those designated by partnership or corporate members. The historical intent and interpretation of this segment of our bylaws has been that voting was done by those present or, in the case of corporate or partnership memberships only, those members representing those corporate or partnership memberships at the AGM. Proxy voting IS legal in our Society only because our bylaws were poorly worded and ambiguous. THE REASON PROXY VOTING MUST BE ALLOWED IS BECAUSE ILLINOIS LAW REQUIRES THE SOCIETY TO "OTHERWISE PROVIDE" EITHER IN THE BYLAWS OR THE ARTICLES OR ORGANIZATION. Thus, because our Bylaws and Articles of Organization do not SPECIFICALLY say "No Proxy Voting" we do not "otherwise provide" and this manner of voting is allowable.

A group of candidates and other members brought up another concern at a meeting of the Board of Directors held on Friday afternoon preceding Saturday's AGM. We were read a New York state legal reference concerning credentials committees and inspectors which has no bearing on us as we are under Illinois law which is quite clear:

107.35 Inspectors. At any meeting of members, the chairman of the meeting may, or upon the request of any members shall, appoint one or more persons as inspectors for such meeting. Such inspectors shall ascertain and report the number of votes represented at the meeting, based upon their determination of the validity and effect of proxies; count all votes and report the results.

A system for acceptance and verification of the number of proxies turned in by various individuals was in place with details available at the hospitality table from 8 a.m. Friday onwards. The Inspectors committee was duly appointed according to

Illinois law and consisted of 4 individuals, each from a different section of the country, none of whom had been introduced to any other inspector or was related in any way to any candidate. The candidates were invited to suggest three additional names for inclusion on the committee.

The second problem addressed at the meeting concerned what the law calls the "Fixing record date for voting":

107.25 "For the purpose of determining members entitled to vote at any meeting of members the board of directors of a corporation may fix in advance a date as the record date of such determination of members, such date in any case to be not more than 60 days and, for a meeting of members, not less than 5 days immediately preceding such meeting. If no record date is fixed for the determination of members entitled to notice of or to vote at a meeting of members, the date on which notice of the meeting is delivered shall be the record date. In lieu of the board of directors from time to time establishing record dates, the bylaws may establish a mechanism for determining record dates in all or specified instances."

On this subject our bylaws, in reference to NEW members says:

Art. IV, (e) Voting. In all matters governed by the vote of the membership, each membership which has been on the rolls of the Society prior to January 1 of the current year, and is in good standing, shall be entitled to one vote.

Our Rule Book states:

"Membership year runs from January 1st to December 31st. In order to vote in that calendar year, new memberships must be received by January 1. Renewals must be received by April 16."

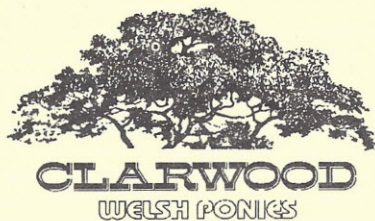
Both dates mentioned above are too early to qualify under the 60/5 concept in the Illinois law. The Society had prepared and brought to Orlando a list of qualified voters according to our bylaws and rules. (This same list had been requested and mailed to one of the candidates in October.) Once the candidates challenged this list on the grounds of Illinois law, it raised questions not easily answered. If, indeed, everyone who paid dues for the first time between January 1 and September 2 IS entitled to vote, then we have effectively disenfranchised around 15% of the membership by not informing them of this right. If all renewals paid after April 16 and before September 2, are also eligible to vote, it makes the situation even more unfair for a sizeable percentage of our membership. Whether we had a complete list of these people in hand in Orlando or not is immaterial because, in fact, there was no way for these people to be informed and allowed to vote at an election scheduled less than 24 hours from the time the subject was raised. More than one of the candidates indicated that they would bring suit against the Society if we held the election without allowing this group the opportunity to vote. No member of the Board has any desire to involve the Society in litigation of any kind. No member of the Board of Directors felt we could hold the election in good faith knowing that even one member (let alone close to 25% involved) had been deprived of the knowledge that they were eligible to vote and the opportunity to do so. (A FAX proxy is not legal.)

IT WAS THIS QUESTION OF ELIGIBILITY OF VOTERS WHICH CAUSED THE ELECTION NOT TO BE HELD. At no time was ANY count of proxies made to determine "who" or "what group" had the most votes. The figure that is being circulated as to the number of proxies present at the AGM is pure speculation--in fact, not all proxies were turned in and NO COUNT of those turned in was or has been made by any person with access to them.

It is easy to say that the "Board should have known". The fact is that all elections for the past 45 years have been held unchallenged allowing votes only from those present and paying dues according to the bylaws and rules. THE REAL POINT IS THAT, HAD THESE CANDIDATES COME FORWARD AS LOYAL MEMBERS AND REPORTED THE FINDINGS AND QUESTIONS RAISED BY THEIR OWN LAWYERS IN A TIMELY MANNER, ALL OF THIS COULD HAVE BEEN EASILY AVOIDED. WE COULD HAVE CLARIFIED AND PRODUCED THE CORRECT LIST OF QUALIFIED VOTERS AND AVOIDED COSTLY MAILINGS AND THE NECESSITY TO HOLD TWO MEETINGS. THE DATE ON THE ONLY LETTER FROM LEGAL COUNSEL WHICH I HAVE SEEN WAS MID-MAY--WE HAVE HAD 2 REGULAR NEWSLETTER MAILINGS SINCE THAT TIME! It is interesting that all of the mailings asking for proxies made by individuals running for election to the board occurred IMMEDIATELY AFTER THE DEADLINE FOR THE LAST NEWSLETTER.

Our attorney has now thoroughly researched our bylaws and practises. The time and place for the continuation of the AGM for the purpose of the completion of scheduled items will be announced soon. A proxy form on which you may designate how your vote will be cast will accompany the notice. This proxy will be in the form of a ballot and will be a secure way for every member to cast his vote according to his own wishes. A complete list of declared candidates and proposed Bylaw changes to be ratified by members will be included. There is one important fact that ALL members should keep in mind. Our Bylaws (wrong or not) were ratified by the membership and this has always been the case. There has never been a "conspiracy" to deny members their right to vote or hold office. The intentions of both the directors and the members has always been to institute rules which would be as fair as possible and IN THE BEST INTEREST of the society as a whole. Notice of all proposed and ratified bylaw amendments/revisions have always appeared in the Newsletter. If members fail to apprise themselves of information, the directors (past, present and future) should not be held responsible. Information is available from our office and is only as far away as your mailbox, telephone or newsletter. Likewise, if any member discovers a problem with our Bylaws, rules etc., it would seem logical that this problem be officially brought to the attention of our office as soon as possible so that it can be properly researched and then made known to the entire membership. Rumors and inuendo can only be counterproductive in our society and simply divert us from our purpose. We appreciate the strong show of support we have received from many of you and ask that everyone consider the possible motives behind the many conflicting reports that seem to be flying around.

1991 ANNUAL GENERAL MEETING

ADVISORY COMMITTEE MEETING Friday, Nov. 1, 1991

An informal meeting of the Advisory Committee members attending the Annual General Meeting in Kissimmee, Florida was called to order by the Chairman, Mrs. Charles C. Abeles, shortly after 8:30 a.m. on Friday, November 1, 1991 at the Ramada Resort in Kissimmee. The meeting was open to observers. committee members present included the Welsh Pony & Cob Society of America Board of Directors, Joan Dunning, WPCSA Honorary Director, Carol Maurer of the Southern California All Welsh Society, Jennifer MacDonald of the Washington Welsh Pony & Cob Assn., Marsha Himler of the Northeastern Welsh Pony Assn., Connie Moore of the Oklahoma-Kansas Welsh Pony Society, Donald Shaneberger of the Welsh Pony & Cob Assn. of New Jersey, Joanna Wilburn of the Southeastern Welsh Pony Assn., Sally Ross Davis of the Mid-South Welsh, Cynthia Kirby of the New England Welsh Pony & Cob society, Stephanie Abronson of the Welsh Pony Assn. of California, Celia Evans of the Southeastern Welsh Pony & Cob Society, and Aggie Seligman of the Gulf Coast Welsh Pony & Cob Assn. Lisa L. Landis, secretary, joined the meeting shortly after it was called to order. Mrs. Abeles began the meeting with questions regarding society policies. One question was if the minimum registration age could be extended to facilitate the identification of white markings, particularly in light-haired ponies. It was noted that the policy currently is to hold the application in the pending file until the markings could be identified. Mary Alice Williams noted that perhaps the deadline could be moved to six months with a discount for those who sent their applications in at four months. Mrs. Dunning noted that the four month date was set in order to ease the rush on the office. It was noted that the majority of the owners could distinguish the markings at an early age. Mrs. Morris noted that when a pony greys, it is usually easier to register them before four months. Mrs. Abeles noted that perhaps a spring shed out notice should be included in the Newsletter asking people to verify the color and markings of their ponies. Mrs. Abeles asked if there were any further questions regarding policies. The life member surcharge was brought up. It was noted that the surcharge had caused much discord. Mrs. Morris felt it should be revoked and asked for the other members' views. The other members agreed that there were strong feelings against the surcharge. Mrs. Evans felt the British Society's graduated life membership fee was a good idea. Mrs. Maurer felt that perhaps the life memberships should be put into a special fund for postage for the Newsletter. Miss Himler stated that she sought legal counsel regarding the surcharge and was told that it is a breach of

contract with the life members. Mrs. Moore felt that memberships were for voting and to register ponies and that it was not illegal to have members pay for the yearbook and Newsletters. Mrs. Sharples agreed with the graduated life system of Britain. Dr. Wilburn noted that the surcharge had been a means of raising money as finances were not as good as they could have been; however, finances were now improved and the surcharge had not generated enough response to validate the strong feelings.

Mrs. Morris noted that thanks to Kerri Mustain's work with the Newsletter, the publication was no longer costing money as it now paid for the printing and postage charges. She also felt that the surcharge would be revoked at the board meeting to be held later that day. It was noted that perhaps some people on the list may be now deceased. It was noted that the office periodically sends a letter to those not active and also takes people off the list when the post office is unable to locate them. Mrs. Abeles asked that anyone who knew of a deceased member to please contact the office.

Mrs. Abeles noted that the members would like more information about the board meetings. She noted that a write up of the board meetings is being published in the Newsletter. Mrs. Abronson felt that it was important to know how each board member felt regarding certain issues so that the members could make informed decisions on the people they would like to have represent them. Mrs. Maurer showed a form used by the IAHA that listed the issues and how the directors voted on them. Mrs. Dunning felt that some explanation of why people voted the way they did would be more helpful than only knowing if they voted for, against, or abstained. Mrs. Verkuyl suggested that the agenda for board meeting could be published in the Newsletter or sent to the clubs so that the members could call the directors about the issues concerning them. Mrs. Kirby felt that there was a mystique about the board of directors that could be broken down by publishing more information about meetings in the Newsletter and that members should be allowed to request copies of the minutes. Mrs. Abeles asked her if she felt that there was an adequate synopsis in the Newsletter. Mrs. Kirby felt that there was not enough.

Mrs. Sharples noted that much of the time spent in meetings was spent reviewing applications. Mrs. Morris noted that there seemed to be some confusion as to the access of minutes. Reading from Roberts Rules of Order, she stated that any member had a right to the minutes of the meeting of the Society, which would be the Annual General Meeting, of which all are members. The same principle applied to the minutes of board meetings, in that their records be accessible to members of the board. Mr. Maurer felt that the Illinois law allowed members access to the minutes. Mrs. Morris felt that this was true if they would come to the office during regular

business hours but that the board was not required to mail the minutes out. Mrs. MacDonald felt that perhaps it might be appropriate to have a liaison with representatives and the board for each region that could discuss items coming up for discussion and would be able to get a more complete understanding via a telephone call than what is printed in the Newsletter. Mrs. Abeles noted that anyone could call any director at any time.

Mrs. Moore noted that perhaps each region could have one director and then three at-large directors could be elected. Mrs. Sharples noted that she, Mrs. Shaneberger and Mrs. Verkuyl had been working on the idea of regional directors. She noted that there were three different formulas by which a breakdown could be found, geographically, membership, and animal population. she felt it was something the members to discuss and decide which area was important.

Mrs. Dunning noted that the area representative program had been set up so that the regions were small. Each region was supposed to have their own meeting and then the representative respond with the issues. That way, everyone had direct input. She felt the breakdown in the system was when the regions did not hold their meetings and respond. She felt that things would not get any better by calling it a different name.

Mrs. Morris noted when the committee's name was changed from area representatives to the Advisory Committee, the clubs began appointing their own representatives. Prior to this, the Board of Directors had appointed the representatives.

Mrs. Williams felt that the advisory committee was a very good idea and that the board did look at the ideas brought forth. However, she did not feel that the board should be regionalized because 95% of the decisions made by the board have nothing to do with regions. The only item she could think of done regionally by the Board was where to hold the annual meeting. All other decisions were made for the benefit of the Society as a whole, and she would not like to have someone on the board who thought only of their own region instead of the whole Society. Mrs. Seligman said that, as a representative, she felt that the representatives needed more information about what the board was doing so that they could pass it on to the members in their region.

Mrs. Moore felt that if the mail vote was passed it would help correct the regional director issue as she felt that the area the AGM was held affected the elections. She felt that there did need to be some system for the regional director and hoped that anyone who cared about Welsh ponies would not be more interested in their region. Mrs. Morris noted that the majority of the directors had first been elected out of their regions.

The next item for discussion was the European Economic Community issues concerning the Welsh pony. Mrs. Morris

noted that the EEC changes were a separate issue from the world-wide harmonization. The EEC harmonization is mandated by law to take place by 1992 and affects all European industries. Mrs. Morris noted that she did ask for input in the Newsletter from members and had not yet received any. Mrs. Morris noted that we could send our stud books, and office-generated sheets for the years not yet published, to the British Society for their acceptance. The requirement is that our ponies must have been properly imported or descendants of properly imported ponies. The definition of properly imported is ponies who left Britain with proper export certificates issued by the Welsh Pony & Cob Society, which is what our Society requires. They are asking us to decide what should be on the black list or the grey list. She only knew of two ponies that should probably be on one of those lists.

Mrs. Carroll asked what the alternative of saying no would be. Mrs. Morris noted that ponies exported to Britain could not be registered there and their US papers would not be internationally acceptable. Mrs. Shemilt noted that artificial insemination may be international in the future. Mrs. Abronson felt that the main question was whether or not we wanted to join and have our ponies registered.

Mrs. Abronson asked that the international meeting information be published in the Newsletter.

Mrs. Carroll asked for a show of hands of the people who were in favor of sending our stud book information to the British Society. No exact count was taken, but it appeared that many were in favor.

Mrs. Abeles noted that the new owner's list apparently was not being distributed by the clubs. It was pointed out that for those who subscribe to the transfer list, new owners were denoted by an asterisk.

Mrs. Abeles moved on to the breed standard concerns. She noted that she had received a lot of interesting response to dropping the bottom limit of the Section B. Mrs. Dunning felt that it was a mistake to drop the height limit. She felt that an overgrown A that looks like a B should be a B and if you have a B that is under 12.2 he should be an A. Mrs. Carroll said that we should be looking at type and if a Section B didn't make his height, it is a sin to put him in Section A to be a representative of Section A of our breed.

Mrs. Clardy felt that a lot of people were registering according to height. She felt it had nothing to do with it and that it was the breeding. She felt that an A x A that exceeds 12.2 is still an A because of its breeding and it doesn't jump up to a B. She felt that it shouldn't be registered or it should be registered as a crossbred and not a different section.

Mrs. Abronson said that a wealth of opinion in the California Welsh Pony Association believed in registering according to size. Her personal belief is that you should register according to the breeding of the animal: A x A = A, A x B = B no matter how big or small.

Mrs. MacDonald said that she represented three groups. One wants to show by size and another wants to register by size.

Mrs. Carroll felt that it all boiled down to protecting the A blood, which everything is

part of. She felt that an A x B might look like an A and do very well at the shows but what it throws later is the issue.

Mrs. Dunning felt that we lose track of the fact that all of the ponies, Section A and B, are descendants from, among others, 13 hand ponies.

Mrs. Abeles noted that the show ring should stop people from breeding something wrong.

Mrs. Shemilt noted that although she doesn't approve of A x B crosses she has a Section A stallion who won grand champion at Tulsa and his full sister, who is a B, also does nicely. Even though they have the exact breeding, she felt that they were completely different.

Mrs. Shaneberger felt that although the A x B issue is important, the members need to be educated as to whether they have A's or B's. Mrs. Carroll agreed and said she felt that although most of the people present understood, many members did not understand the differences in type. Mrs. Abronson agreed that it is an educational problem that needs to be addressed as soon as possible.

Mr. Orear noted that this issue had been studied by the board for several years. He mentioned the questionnaire that the members were asked to fill out. He noted that the dropping of the height limit of B seemed to be the best solution. He felt the board didn't do it because they liked it, it was done because the general membership's opinion was to drop the limit.

Mrs. Moore noted many people in her area had bought ponies for their children based on performance and then decided to breed them. She felt that they needed a place to show ponies but that showing a small B as an A is wrong.

Mrs. Himler felt that an A x B should not be an A if it is under 12.2 because it still has the genetic potential to sire a B. She felt that the members needed definite breed standards.

Mrs. Abronson felt that perhaps we should start licensing stallions.

The meeting was adjourned at 11:45 a.m. and the issues were to be taken up during the round table discussions.

MINUTES OF THE BOARD OF DIRECTORS' MEETING Friday, November 1991

The meeting of the Board of Directors of the Welsh Pony & Cob Society of America, Inc. was called to order by the President, Gail E. Morris, at 1:22 p.m. on Friday, November 1, 1991 at the Ramada Resort in Kissimmee, Florida. All directors were in attendance as were Mrs. Dunning, Honorary Director, Lisa Landis, Secretary, and Stephanie Abronson, guest.

PRESIDENT'S REPORT - The President expressed her appreciation to the directors for their efforts during the trying time in which the ambiguity of the by-laws regarding proxies had been discovered. She felt that the multitude of talents from

the directors had been exceptional. **READING OF THE MINUTES** - The President asked if the Board would like the minutes of the last meeting read. Dr. Wilburn moved that the minutes be accepted as mailed. The motion was seconded and passed unanimously.

SECRETARY'S REPORT - The President read the Secretary's report (filed herewith). The President said if there were no objections to having the member-breeder directory advertising sheet in the Summer Newsletter, Mrs. Mustain could do so next year. The President asked the Secretary to send a reminder to the AHSA regarding the report. Rhoda Verkuyl asked if each member would be mailed a copy of the by-laws when they were reprinted. The President noted that due to the cost of mailing, a notice would be published in the Newsletter stating that they were available upon request.

TREASURER'S REPORT - (The report is filed herewith.) Dr. Wilburn gave the Treasurer's Report. She noted that the finances were up. She went over the proposed budget for 1992. She stated that \$8000 had been budget for the stud book account in addition to the funds already there. The President referred to the By-Law Article IX - Monies and noted that promotional programs need to be self-supporting as the stud books must be our first priority.

COMMITTEE REPORTS
ADMINISTRATIVE - (The report is filed herewith).

The President reviewed how the proxy situation came about and reviewed the by-laws and Roberts Rules of Order and the Illinois law regarding proxies. She stated that a letter had been mailed to every voting member. She reviewed the system for checking the proxies and the tellers committee nomination (Jean Merchant, Chairman, John Almond, Jackie Hubert, and Mary Jensen). The President asked if the Board would like to ratify the nominations. Mrs. Sharples moved that the committee be appointed as such. The motion was seconded and passed unanimously. The President read the legal opinion from the attorney regarding the tellers committee.

At 2:36 p.m., the candidates for election to the Board of Directors and several observers joined the meeting. The President welcomed them and asked if there was a spokesperson. Campbell Lawrence signaled that he was and that there were a few issues they would like to work out to make the AGM go as smoothly as possible.

Cynthia Kirby stated that the proxies should be verified according to the validity of the member and the date. She stated that there should be an inspectors committee and a credentials committee. She felt that the candidates would be agreeable if these committees could be appointed by both the candidates and the Board. She discussed a system in which proxies should be collected alphabetically and checked off an alphabetical list of members. She felt that each proxy holder could request the number of ballots corresponding with the number of proxies they hold when they give their proxies to be verified. As each member enters the meeting, they could receive their personal ballot.

The President noted that some of Mrs. Kirby's ideas were redundant with the plan established by the Board. Mrs. Kirby felt that the problem with the Board's system was that the proxies should be validated after the election, not before. The President noted that the handing out of ballots was the final verification of the proxies. Mrs. Kirby asked who would do the validating. The President stated that the tellers committee would do this. Mrs. Kirby felt that the tellers committee and the inspectors committee should be two separate committees. The President noted that the system put forth by the Board had been drawn up on the advice of the Corporation's lawyer who said that the Corporation must appoint an inspector or inspectors and they determine the validity and effect of proxies and the results of the voting. The President asked if there was a specific objection to any tellers committee member. David Maurer felt that the candidates would feel more comfortable if they could appoint some people to the committee. The President noted that the appointing of committees in incumbent upon the Board of Directors. She explained how the four members of the committee had been selected geographically and that none of them knew the other members. Valerie Lopicola stated that it was the Board's right to appoint the committee, but that it could be challenged. Mrs. Morris stated that was what she was asking for, if there were any objections to any committee. Mrs. Kirby noted from a New York legal reference she had stated that the inspectors of an election could not determine the genuineness of a proxy. The President noted that she had been referring to the Business Corporation Act of Illinois. Mrs. Kirby then read a section regarding a credentials committee from Roberts Rules of Order. The President noted that Roberts Rules of Order is not cited in the Society's by-laws and that the Society must follow the Illinois statutes. The President asked if the candidates would like to submit two more names for the tellers committee to be ratified by the Board. Pat Clay and Stephanie Abronson were both suggested. Neither had an objection to being appointed to this committee. The President asked if the candidates felt that there should be an even or uneven number on this committee. Mrs. Dunning noted that each member would have to agree. The President stated that each member had been advised that they were being asked for an extremely accurate count that was absolutely fair, honest and correct. They were also being asked to sign a report. It was asked whether or not this committee would also verify the proxies. The President stated that they would. It was stated that the Fall Newsletter had said that membership for voting purposes is established from January 1, 1991 and prior to. It was asked if only those memberships up-to-date on January 1, 1991 would be allowed to vote. The President noted that the deadline for renewing memberships is April 16th. She read the first from By-Law Article IV - Meetings - Members, under section (e) Voting. She noted that in this case, members would have to be on the rolls prior to January 1, 1991. She said that

if you paid your renewal dues before the deadline you could still vote. She said that it was new members that had to be members prior to January 1. Mrs. Kirby asked where the April 16th deadline was stated. The President noted that the by-laws do not deal with renewal memberships, only new memberships. The April 16th deadline in in the rule book as it is a rule and not a by-law. Miss Lopicola stated that she had consulted Illinois corporate counsel and had been told that the April 16th deadline had been set up for housekeeping purposes and the by-laws must be followed. Her counsel felt that this was a constitutional matter and not just an Illinois corporate matter. She stated that if a person was a member prior to January 1 and was in good standing -- has paid their dues and are not in debt to the Society -- they have the right to vote. She stated that the rules are not the same as the by-laws and that the rules were not binding in the way that the articles of incorporation and the by-laws are. The President noted that legal counsel would have to be taken on this point which would delay the election. The President asked the Secretary if many people had renewed late. The Secretary noted that there were several people who had renewed after the deadline but she could not give an exact total at that time. Miss Lopicola noted that her counsel had stated that the Society was disenfranchising a member who was in good standing. He said that the by-laws could be changed but the rules do not have the authority of the by-laws. The President noted that if the lawyer found this to be true, the list of members who renewed after April 16th was not at the meeting. she asked what the candidates would propose the Board do. Mrs. Kirby noted that she, personally, did not see how an election of this import could be carried out unless there is a valid voting list. Mrs. Clay removed her name from the tellers committee. It was noted that it was still business hours and the Society could call the office and the lawyers and have the list sent. The President noted that she did not know how many people had renewed. She asked the Secretary. Mrs. Landis noted that proxies had been received from people who renewed after April 16 and that those proxies were returned. The President noted that those people would have to be given a chance to resubmit their proxies and she did not see how there could be an election. Marsha Himmler noted that the by-laws state that these by-laws are governed in all respects by the Laws of the Commonwealth of Virginia. She had obtained legal counsel that stated that new members who pay their dues within 70 days of the meeting had the right to vote. The President noted that the Society is governed by the laws of Virginia so long as they are not in conflict with the laws of Illinois. Mr. Maurer noted that the Illinois law states that new members on the rolls prior to 60 days of the meeting can vote. Jennifer MacDonald asked if it were possible to find out who the people who had renewed are. It was noted again that proxies had been returned to some people. It was also noted that the lists that had been sent to the candidates was inaccurate and that only members the Society perceived as

eligible to vote had received a letter regarding the proxy vote. It was asked if the by-law amendment for mail was passed, could the election be held by mail. The President noted that this vote could not be taken either until the legal voters could be clarified. Miss Lopicola noted that a letter had been circulated in California that could be construed as a willful misrepresentation as the letter said a group of malcontents had discovered a little known tradition of Illinois that allows proxy voting. She noted that the letter had contained a proxy form and neither the letter nor the form mention a date. She recommended that the Board of Directors consider publicly withdrawing their support from that action as it was co-written by a Board member. The President noted that as long as the signer wrote in the date on the form, it was legal and it did not have to have a specific blank for the date. Miss Lopicola asked many of the directors knew the contents of the letter written before it was mailed. The directors all denied knowing anything about the letter. Miss Lopicola said she felt the Society should not validate this behavior by counting the proxies. The President replied that the Society is obligated by law to count legally executed proxies. Mr. Maurer referred to the Business Corporation Act of 1983 of the state of Illinois, section 7.55, proxy solicitation. He felt that because the letter mailed from the Society office did not specifically name the slate of candidates, the letter was misleading as the members did not know specifically who the Secretary would vote her proxies for. He suggested that it would be in violation of the Business Corporation Act if Mrs. Landis did cast her ballots for directors. Mr. Maurer noted that he had told the people exactly how he intended to vote their proxies and, as the Society had not done this, it would be in violation of the law. The President replied that it would have to be decided in a court of law. Mr. Maurer felt that Mrs. Landis should be instructed to only vote for the by-law mail vote and not the board of directors or the count could be tied up for years in a court of law. The President noted if that were to happen, it would be effectively killing the Society and that she did not feel that the Board could betray the membership that had signed those proxies. Connie Moore felt that it would not be right to invalidate the proxies sent to the Board. She also felt Miss Lopicola was correct, the by-laws had to be followed. she was asked if it would be impossible to vote the next day. She felt so. Miss Himler asked if the nominations committee had developed a slate of candidates. The President asked if there were any objections to the nominations committee giving their report. There were none. Dr. Wilburn reported that the slate of candidates would be Mr. Orear, Mrs. Reese, Mrs. Shaneberger, and Mrs. Moore. The President explained that the ballots had been changed for this election. All of the suggested nominations were printed on the ballots and there was room for a write-in nomination suggested from the floor. Miss Himler stated that a constituent had asked her to ask what the by-laws mean when referring to two producing

broodmares. Dr. Wilburn stated that this was open for discussion. The by-laws did clarify if the mares had to produce purebred foals, whether or not the foals had to be registered, and whether or not two foals had to be born each year. Carol Maurer asked if the by-law amendment for mail voting was passed, could the election be handled this way. The President noted that she wished that this were true but the by-law amendment could not be voted on without a valid membership list. She asked if there were any further comments. As there were no further comments, she thanked the members for attending and asked that they allow the Board to have an executive session without spectators. The members cleared the room.

Note: From this point on, the Board of Directors met in Executive Session.

ANNUAL GENERAL MEETING MINUTES Saturday, November 2, 1991

The Annual General Meeting of the Welsh Pony & Cob Society of America, Inc. was called to order by the President, Gail E. Morris, at 1:50 p.m. on Saturday, November 2, 1991 at the Ramada Resort in Kissimmee, Florida.

The President welcomed everyone and asked each person to introduce themselves. The President extended the thanks of the assembly to Mary Alice Williams and Celia Evans for organizing the activities.

The President announced that the Board of Directors had designated Coleman Cowan and Polly Swinerton honorary directors for life. Mr. Cowan is a former director and president of the Society and owns CC Welsh Ponies in Lubbock, Texas. He was unable to attend the meeting, but his certificate will be mailed to him. Mrs. Swinerton is a former director who resigned for personal reasons earlier this year. Mrs. Swinerton thanked everyone as she accepted her certificate.

The President asked the Secretary to read the minutes of the 1990 Annual General Meeting. The minutes were read in their entirety. The President asked if there were any corrections. Connie Moore stated that when discussing the life surcharge, she was not referring to the Oklahoma-Kansas club but rather the Oklahoma Dressage Society. The President asked if there were any further corrections. There were none. Agnes Seligman moved that the minutes be accepted as corrected. The motion was seconded and carried.

The President asked for the Treasurer's Report (filed herewith). Dr. Wilburn, Financial Committee Chairman, reported the checking account balance as of 10/16/91 is \$10,880.15, the stud book account balance as of 10/16/91 is \$6,270.78 and the capital fund balance as of 10/16/91 is \$2,129.52. She stated that the financial statements had been prepared and anyone wishing a copy mailed to them could sign the sheet on the table. Copies of the budget had been distributed. She noted that some great strides had been made on the financial situation within the last year. \$8,000 has been budgeted to be added to

the stud book account and provisions for a capital cash fund have been made. She announced that the board voted to rescind the life surcharge earlier that afternoon. This had arbitrarily been removed from the budget as it had not generated much income and was ill-received. She asked for any questions.

David Maurer asked if a stud book was not going to be published as the income did not reflect the sale of a new issue. Dr. Wilburn noted that this budget was made as conservative as possible but that the stud book was in the final stages and would hopefully be out shortly. The funds were available for this issue.

Jennifer MacDonald asked if the life member surcharge would be credited to those who have paid. Dr. Wilburn stated that it had been in effect for one year but those who have paid the 1992 fee would be credited.

ADMINISTRATIVE COMMITTEE - The President asked Kathy Reese, Chairman to present the Administration Committee Report (filed herewith). Mrs. Reese reported that the computer is on-line, the rule book has been revised and reprinted, registration and transfers are up, with half-Welsh showing the largest increase. Pam left the office in September and Felicia is now working an additional 20 hours, for a total of 60 hours, as Bookkeeper/Assistant Secretary and Registrar. She asked if there were any questions.

Mrs. Morris explained that this committee was established earlier this year and receives regular reports from the office containing such items as number of applications received, processed, and placed in pending; needs of the office; and turn-around time.

Valerie Lapicola asked what the turn-around time is currently. As this is our busiest time of the year, the turn around time for correct applications is about seven weeks and two weeks for correct transfers. Miss Lapicola asked about Felicia's working 60 hours a week. This has been cleared with the labor board and Felicia has been made a salaried employee. She did not have to be trained as she was already familiar with the office. This has also cut labor hours from 120 per week to 100 hours per week. The computer and the moving of the Newsletter has eased the workload on the office. Mrs. Abeles noted that someone had asked her about the office turn-around time, and she had looked that particular case up and it had taken five weeks. Mr. Orear noted that some applications were being held in pending until the leg markings could be distinguished. These applications can be submitted at the four month deadline and held until the markings are more clear.

QUALIFICATIONS COMMITTEE - The President asked Hetty Abeles, Chairman of the Qualifications Committee, to explain the new committee which streamlines the time spent at Board meetings. Mrs. Abeles reported that the committee looks at the more difficult items received in the office. She gave examples such as disputes regarding transfers, belly patches, and color questions. She noted that they were careful to avoid legal matters between members. The President noted that if rules are already in place, the Qualifications Committee makes a recommendation as to

whether the application should be accepted or rejected. If there are no set rules regarding the matter, the Committee prepares and presents an outline of the problem, along with any recommendations, to the entire Board for its decision. Pat Clay asked if the incomplete penalty fee had helped with incorrect applications. It has not.

The President noted that the application for registration has been redesigned with the help of Agnes Seligman and other members to make it more readable and easier to follow.

CORRESPONDENCE COMMITTEE - The President asked Jean Shemilt to explain the Correspondence Committee as this is also a new committee. Mrs. Shemilt explained that the Correspondence Committee deals with the more difficult correspondence received by the office. The President also noted that Mrs. Shemilt is the Correspondence Chairman for the entire Board and answered letters addressed to the directors.

STUD BOOK - (The report is filed herewith) Mrs. Dunning reported that the stud book had taken longer to prepare than expected but was in the final stages. When this issue is completed, work will begin immediately on the next three years, and it is expected that this will go much better. In answer to Mr. Maurer's previous question, Mrs. Dunning stated that she felt perhaps we may even be able to publish two studbooks next year. Besides the improved technique of the office and the Stud Book Committee, she felt it would also help speed things up if the owners would make sure that they mean exactly the same thing by what they say as the office thinks they mean when describing foals. She stated that in connection with this, Mrs. Abeles had something she would like to say.

Mrs. Abeles felt that many people were mistakenly calling a pony roan when, in fact, it was turning grey. If white hairs are coming in around the pony's nose, it is not a roan. It will grey. She felt owners must start looking more closely and not give animals a gene they don't have. Regarding colors, Mrs. Abeles felt that we need to better describe dun such as black dun, brown dun, and cream dun. She also felt that many people were describing dark brown ponies as black and, although we don't have a lot of liver chestnuts, those should be called liver chestnut and not dark chestnut. Liver is used to describe ponies that are the color of raw liver with no red or black. She suggested looking into the pedigrees. Another item that she felt would help the Stud Book Committee's proofreading would be if names were spelled in the traditional way. If uncommon spellings are used, the proofreader must recheck to make sure it was actually registered that way or if it is a typing error. Valerie Lapicola suggested that perhaps an editor of a book written on color would allow the Society to use the color cards to help members better understand the different colors. Although this would be expensive, the books could be sold for a few dollars to those who were interested. Wayland Carlisle described a book that he used which shows colors and markings of Arabians. The President noted that the revised applications had leg drawings which included lines and the appropriate

definitions.

Mr. Hubert asked when compiling three years of stud book at a time if it would be possible to list the sections together in alphabetic order for all three years, such as all three years of Section A stallions. Mrs. Dunning felt that would not be difficult to do while we are behind, but once the stud books were caught up, we would have to wait three years before the proofreading could be started.

Mr. Maurer felt that since the stud books were a few generations back perhaps registrations could be listed in the Newsletter or set up similar to the transfers list. The President said she was not sure how the computer was set up but that it would be looked into. Maureen Lopicola felt that if something like this could be done, the breeders could pick up on mistakes in spelling, color, etc. and let the Stud Book Committee know. The President felt that these were good ideas and asked Miss Lopicola if she could write them up and submit them to the office to be passed on to the Stud Book Committee so that none of the points made would be left off. Mrs. Morris also noted that Kathy Reese had volunteered to look up any pony in this country or Britain to help with pedigree searches until the stud books can be caught up.

John Almond felt that the stud book photographs should be more expensive than \$10, say \$50-\$100. Mrs. Dunning reminded him that this was not advertising and photographs could be rejected. He felt that it would not be unreasonable to reject a photograph and ask for another one.

Pat Clay said that the Canadian society auctions off the rights of their stud book to help pay for the cost. The President asked that Mrs. Clay send the details in writing for the consideration of the Stud Book Committee.

Connie Moore asked if the price had been set for the new stud book. The final cost figures have not been received so the price has not been set. The price will be close to the cost.

ARTIFICIAL INSEMINATION & EMBRYO TRANSFER - (The report is filed herewith) Dr. Wilburn reported that currently 30 stallions have AI permits: 9 Section A, 12 Section B, 1 Section C, and 8 Section D. In addition, two stallions who had permits have since been gelded. Four foals conceived by artificial insemination have been registered. Currently, four mares have been issued embryo transfer permits: 3 Section A and 1 Section B. One foal was registered through the embryo transfer program owned by Mollie Butler. Mrs. Butler reported that the foal had died of a fractured skull after hitting its head while being wormed. It was noted that the foal, GlanNant Glynda, was the first embryo transfer Welsh pony registered in the world.

SHOW SANCTIONING/HIGH SCORE COMMITTEE - Mary Alice Williams reported that 20 shows were sanctioned in 1991. Two bronze shows did not have enough ponies to qualify for rating. Mrs. Williams reported that with the assistance of Connie Moore, Lisa Landis would be taking the points tabulating back into the office. Connie Moore reported that she had not received all the necessary items from a few shows. Mrs. Williams said that anyone

could contact either Mrs. Moore or Mrs. Landis to work on getting the last few items in.

Jean Shemilt reported for the AHSA Liaison that the pony leading rein and child's first pony class rules had been passed by the AHSA. She noted that two new items have been presented for changes. The first being the requirements for judges under Article 1012 which specifies 15 questionnaires be returned for each judge applicant. This was felt to be difficult for Welsh judges as they are a smaller group. It was asked that this be amended to read "In the Welsh Pony Division, 10 recommendations must be received, and applicants must be recommended by at least three members of the current AHSA Welsh Pony Committee." The second request is that the Welsh cob Section D be added to Articles 121 and 122 under "Exceptions" because some of the Section D cobs are under 14.2 and some are over. The results of these requests will be learned on Monday, November 4.

Stephanie Abronson asked if there could be a way all sections could show together. The President said it could be done through miscellaneous open classes restricted to ponies registered in the WPCSA. Ruth Verkuyl asked if in the Society's high score program a cob could show in Welsh Pony English Pleasure. Mrs. Abeles responded that it depended upon whether or not the show management wanted to restrict the class to certain sections. Mary Alice Williams stated that in reasonable sized classes Sections A & B could show together and Sections C & D could show together. She also noted that it was being considered that, in cases where there were inadequate entries for separate classes for silver and bronze shows, that all sections could be combined as well as junior and adult riders be combined.

Mrs. Williams noted that the high score rulebook was going to be revised shortly to adjust for the changes from Section A and Section B to 12.2 and under and over 12.2 to 14.2.

John Almond asked what the feelings were as to the combining of Section A & B in the same classes. Maureen Lopicola noted that ponies have been registered by size and now they were going to be shown by size rather than section. She felt that the same ponies were going to be in the same classes but one would have an A on its papers and one would have a B. She felt this would cause no additional problems. Wendy Petersen noted that the people in the Ohio area have been doing a great deal of work in open shows with Welsh draft heavy harness classes and wondered if perhaps there was some way to get these sanctioned. The President noted that she had been to Ohio and seen the tremendous work that area was doing. Mrs. Williams said she would be glad to work with them on this matter and asked that Mrs. Petersen send her some more details and information. Connie Moore noted that people could use the open division classes of the WPCSA high score awards for their classes at other breed shows.

Jennifer MacDonald asked whether there could be a regional advisor system for the Show Committee as each region's showing styles are different. Mrs. Morris noted that

this was a very good idea and perhaps this could be worked up through next year's round table and advisory meetings or by mail committee. Jay Hubert agreed that this was a good idea. He said that he and several other people had been discussing the idea the day before and all agreed that they would be willing to serve in some capacity to assist the Show Sanctioning Committee. Connie Moore had made notes of the ideas and will pass the notes and names of the people willing to serve to Mary Alice Williams.

Valerie Lopicola asked for clarification for the \$1 per animal fee. The President said that the fee was per animal, not per entry. Mrs. Abeles noted that animals at shows with double breeding classes would have to pay twice.

Connie Moore reported that some people feel that the 40% conformation for performance classes should be lowered to 25% or used only in case of a tie. It was felt that this discourages some from showing in performance. The President noted that this is a long running issue with feelings both for and against. She noted that some also wanted to raise the percentage in breeding classes. She noted that there are some classes in which the conformation does not count. Jennifer MacDonald noted she also felt this is a problem that needs to be dealt with. Mary Alice Williams said that it would be looked into but that, in the meantime, the shows could add more working classes or classes with conformation not to count. Mrs. Abeles felt that if the percentage was lowered, perhaps it should not be as low as 25%.

Mrs. Abeles gave the A&B show rules report. Mrs. Abeles discussed the length of feet and weights and requests for more variety classes in western pleasure, English pleasure, and pleasure driving. She also noted that it had been requested that hitch judges be used for hitch classes.

UNITED STATES DRESSAGE FEDERATION LIAISON - Carlene Sharples, Chairman, reported that the USDF awards were creating interest for Welsh ponies and cobs. In the last year, she has received 23 telephone calls from members regarding the program as well as 18 telephone calls from people who do not currently own Welsh ponies or cobs. She noted that Linden Gray, a member of the US Dressage Team, had written her expressing interest in Welsh ponies and cobs for dressage.

HISTORIAN - Miriam Williams, Historian, noted that she has received articles from all over the country. She said would like as many articles as possible. She would like to have articles from US or Canadian publications rather than from Britain, unless they deal with animals imported. Jennifer MacDonald asked if it were possible for a list of Historian articles be published in the Newsletter and copies of the articles be made available to the public. Miss Williams said that her time was limited, but she would work on this.

PUBLICITY - The President announced that the International Show, to be held August 1992 in Britain, had invited Mrs. Abeles to judge. The President said this is a prestigious show and should all be proud of Mrs. Abeles for being asked. Kathy Reese, Publicity Committee

Chairman, reported that Kerri Mustain volunteered to produce the Newsletter. Mrs. Mustain has put a great deal of work into the publication and has developed an eye-catching new format with photographs. Her efforts have saved a lot of money and time spent in the office.

Mrs. Reese also reported that the 1991 yearbook is available and any person or group interested in putting out a yearbook is invited to contact the office. She noted that, unfortunately, as with the 1991 yearbook, any deficit would be the responsibility of the editor or editors. Mrs. Reese stated that a file of general interest or explanatory articles and photographs from publications primarily from the horse industry is being developed. She also asked people to send in performance photographs that could be kept by the Society and submitted with articles.

Dr. Wilburn noted that during the round table discussions, a suggestion was made to combine the member/breeder directory with the yearbook to save money and prevent duplication of effort. During the round table discussions, Mr. Maurer had graciously volunteered to help. Mrs. Reese felt that was a possibility that could be further explored.

Pat Clay suggested a contest to obtain photographs. She said that the Canadian Society had done this and received over 100 photographs.

Carlene Sharples noted that she had been contacted by Western Horse to do an article on Welsh Cobs. She would like to include as many photographs as possible and asked that anyone interested who had action photographs of cobs send them to her within the next 30 days.

YOUTH - The President noted that Karen Hughes is the Chairman of the Youth Committee and she had been doing a youth program through the Newsletter. A report from Mrs. Hughes was not available.

ADVISORY COMMITTEE - Mrs. Abeles reported that the committee had discussed several policy questions. The need was expressed for a more detailed breed standard and more publicity. The topics of discussion were extended on to the round table discussions. Mrs. Abeles asked Stephanie Abronson to share her notes on some of the topics discussed there.

Mrs. Abronson said it was felt that the Society's literature needed updating with better definitions and illustrations. It was also felt that the measurement for breeding classes must conform with the breed standard for height. The A x B crosses were discussed. It was suggested that a medallion could be used with the pony's name in advertising to show that it was of A x A or B x B breeding. The Canadian method of putting the percentage of cob blood on the registration certificate was discussed.

AGM AUCTION - J.D. Orear thanked everyone who helped with the auction. He reported that a little over \$3,700 was raised. The President thanked Mary Orear and Reva Herman for being the auction clerks.

KENTUCKY HORSE PARK - Stephanie Abronson reported that the exhibit was in exceptionally good shape and had been up every day for the past year. The exhibit pony, Rajon Silver Streak, has been retired

due to personal problems. He is residing with Nancy Cole DVM, in Lexington, Kentucky. He has temporarily been replaced by Aquila Saccharin (aka Sugar) owned by Claudia Novak. Sugar is an 11 year old Section A mare (11 hands). As Sugar is only on temporary loan, if anyone has a pony they would like to donate to the park, it would be much appreciated.

JUDGES LIST - Janis Shaneberger, Chairman, reported that the program has been well-received. We are now at the stage where we would like to receive the evaluations of the judges. She encourage all shows to send in evaluations of each judge, both provisional and approved so that a rating system can be developed. She asked for suggestions for the rating system. She noted that the membership requirement for judges had brought in a considerable amount of income. Tizzie Benedict asked if there is a way for the judges to get some feedback from shows. Sabra Schiller suggested that the evaluations be done in duplicate with a copy to the committee and to the judges.

BY-LAWS COMMITTEE - The President for the committee's report. Rhoda Verkuyl, By-Law Committee Chairman, deferred to the Chair. The President read the following statement:

"I have been directed by unanimous decision of the Board of Directors to report that it was brought to our attention yesterday afternoon by candidates for election to the Board of Directors that the Society's list of eligible voters may be deficient according to our by-laws. In order for the Society to provide every eligible voter the opportunity to exercise his rights, time constraints dictate a postponement of this election. The by-laws need to be revised before being voted on by the entire membership. To this end, legal counsel has been retained. A special meeting of members will be called to ratify these by-law revisions and to elect directors. All members will be properly notified of the place, time and agenda for the special meeting. The directors regret not being able to finish the business of this annual meeting."

Meredith Mackay-Smith moved that the meeting be adjourned. Janet Montgomery seconded the motion. Cynthia Kirby asked for a point of order. The President noted that this motion was not debatable. Jay Hubert called for the question. The President asked for an oral vote, the results of which could not be discerned. The President called for a standing vote. The motion carried with 40 for adjournment and 15 opposed. The President adjourned the meeting at 4:15 p.m.

We have received some clarification of the information concerning the EEC situation. Mr. Pritchard (WPCS, Secretary) has written to say

"Recognition of organisations which maintain or establish Stud Books by the EEC bureaucracy will be subject to their compliance of the principles laid down by the organisation which maintains the Stud Book of the origin of the breed." In this case, it is of course the British society. He further states that the British Society will not be affected by the EEC Harmonisation regulations because it is their rules which will be in force. Also, they will not be accepting ponies and cobs bred in other countries into the British Stud Book but those accepted under the "relaxation" procedures would have any progeny eligible for registration which is internationally acceptable. This means that the animals will continue to be registered in their own country but will also be internationally acceptable. The most important aspect of this Relaxation, Mr. Pritchard adds, is to facilitate the use of A.I. around the world, particularly in those countries where the gene pool is small.

The WPCSA office is updating its membership list and requests that members inform them of any deceased members they may know of.

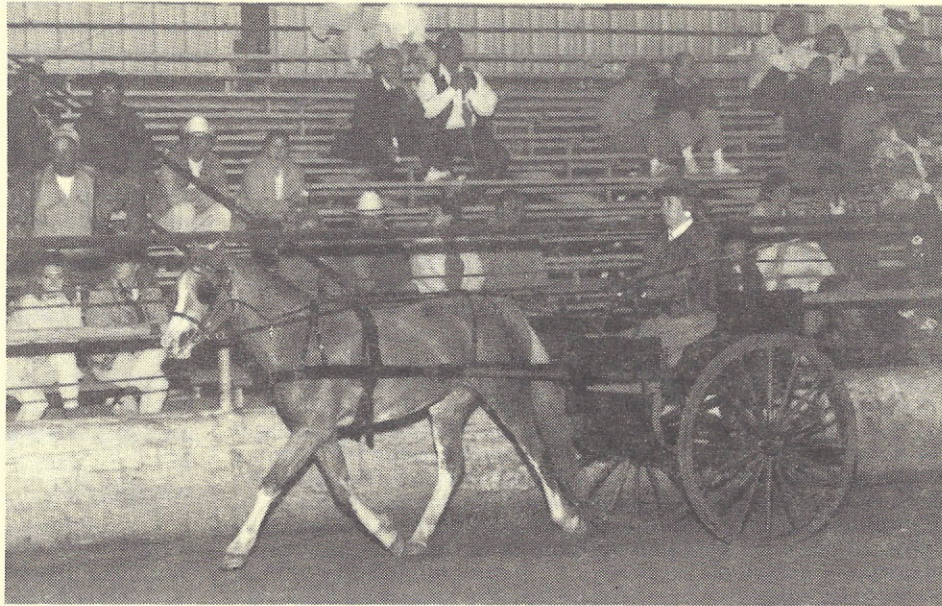

RECOLLECTIONS

Sometimes we need only look to the past to better understand the present and future. Our breed has a rich history of ponies and personalities. Members have sent copies of old articles which will be published from time to time. I hope you will enjoy reading them as much as I have. The following article is from 1973:

BREED TYPE - SECTION B

by: The Late Mr. Mountain of Twyford Stud

Every Fayre Oaks sale is extraordinary for one reason or another. This year (1973) the total receipts came to £136,000, exceeding the previous record by £37,000. The outstanding talking point this year was the remarkable similarity in type between many of the top priced Welsh Ponies (Sect. B) and many of the top priced Part-Breds. Indeed, many of the Part-Breds showed more Welsh characteristics than some of the registered Welsh Ponies. There is a wide-held theory which explains how this odd state of affairs has come about, but as it is based on pure speculation and not on proven facts I do not propose to spell it out.

An extract from the Society's official brochure has this to say about the Welsh Pony: "A larger edition of the Mountain Pony. It is now in great demand as a child's second pony, having all the attributes of the modern riding pony while retaining the type, character and hardiness of the native pony. It is the ideal foundation from which to breed the larger type of riding pony."

I will label the ponies which conform to this description as the "true" type.

As we saw at Fayre Oaks, there is a second type, many of which closely resemble some of the Part-Breds. This I will call the "refined" type.

The existence of two such dissimilar types in confusing to breeders and utterly bewildering to the general public and especially to those from overseas. To add to the confusion, both types are entered in the same section of the stud book and both compete against one another in the same show classes.

It seems to me that it would be desirable to separate them. At one time Sec. A was divided into two parts: Part 1 was for ponies not exceeding 12 hands and Part 2 for those not exceeding 12.2 hands. To divide the present Sec. B ponies by height would not be practical. To divide them by type would make a lot more sense, but I don't see how it can be done.

I see no reason why those who prefer the refined type should not continue to breed, register, exhibit and sell for satisfactory prices the ponies of their choice.

I am however sure that it is the duty of all judges, who have accepted an invitation to serve on the Society's panel of judges, to put up the true type and put down the refined type. Of course there may be occasions when ponies of the true type have such defects of conformation that the refined type must be preferred.

It is not the duty of a judge to place first the pony which he himself prefers. He is acting for the society on whose panel he has agreed to serve and that Society has laid down a certain specification. If the pony he personally prefers does not conform more or less to that specification, he must put it down.

This may mean that a judge may have to put down the pony which, if given the choice, he would like to take home and, moreover, the pony which, if sold at public auction, he considers might fetch more than his first in line.

If there are any judges not prepared to put up those ponies which most closely resemble the society's official policy, there seems no object in going to the considerable trouble of compiling a judges' panel. Let anyone come and sort them out.

This problem of true type and refined type is not peculiar to the Welsh.

On one of the rare occasions I have been able to attend the National Pony Society Show as a spectator, I watched the judging of a good many native breed classes with the late Major K.P. Wallis, who was a highly respected judge of most breeds of ponies as well as Hunters and Thoroughbreds and could sum up the good and bad points of an animal quicker than anyone else I have met.

I remember remarking on a very nice pony which was standing at the bottom of a line of Connemaras. On examining the rest of the class it became clear it was correctly placed. Although a very nice pony, it lacked all Connemara characteristics. Major Wallis told me he frequently had the same problem with New Forest ponies. One or two very nice ponies turned up, but they lacked all breed character and he, rightly in my view, put them down.

If all breed judges make a habit of putting up the refined type and breeders react by producing that type, not many years will pass before the Connemara, the New Forest and the Welsh Pony will become practically indistinguishable.

FIRST REGISTERED WELSH EMBRYO TRANSPLANT IN AMERICA

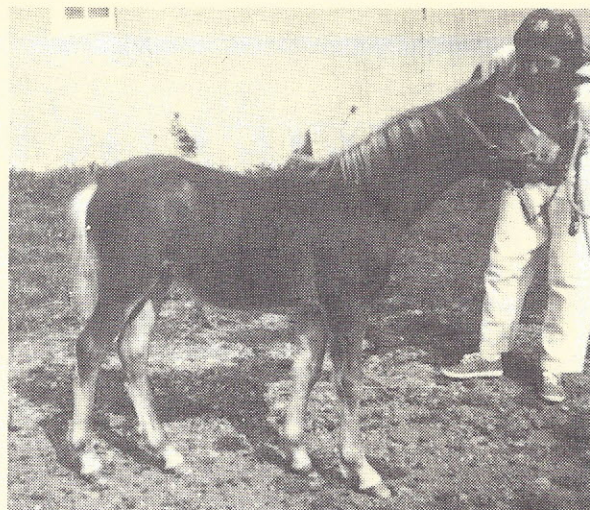

Since we are the first and only American Welsh breeder so far to succeed in an embryo transplant of a purebred registered Welsh foal, I thought a description of the process as well as our problems might be of interest to others. With the help of the Cornell University Baker Institute at Ithaca, New York, we were able to get one viable embryo transplanted out of five attempts. The process was as follows:

First a blood type on the mare and stallion to be used and a statement of intent to attempt embryo transplant and accompanying fee had to be sent to the WPCSA two weeks before the attempt. Then it was necessary, using ultrasound and hormones, to have the donor mare and the recipient in the same phase of breeding cycle.

Next a donor mare was bred to the stallion and, after 7 days, the mare was tranquilized and a solution put into her uterus. This solution was then allowed to drain into a container which had a special strainer in a cup. The cup was then marked in sections and put under a microscope. When the fertilized egg was found, it was then transferred to the uterus of the recipient mare. About a month later our recipient mare was ultrasounded and found to be in foal. The landmark Welsh foal was due the end of May, 1991. The vet told me that an embryo transplant foal was apt to be a week late. This made our due date June 8th, the day I was supposed to be in Kansas City for a WPCSA Board of Directors meeting. Luckily, I decided not to attend.

On June 8th, at 6 AM, I went out in the pasture to check on the surrogate mare. The mares were down at the far end of the field where a small brook flows. All appeared as I had left them the previous night. While walking back to the barn I came across a placenta on the ground. Shocked, I started searching for a foal. I looked in the wooded area on each side of the fence. A plot of grass down in a gully

near the brook appeared to be well trodden and I discovered the frightened filly under a canopy of bushes standing in water up to her knees. Apparently she was hiding from her surrogate dam who had attacked her. The filly and mare were taken back to the barn where we gave the foal colostrum and tried to restrain the mare so that the foal could nurse. The mare became progressively more aggressive toward the foal during the next two weeks. In the meantime, GlanNant Glynda, as we named the filly, learned to drink from a pail. The mare was returned to Cornell and I started a 3 to 4 hour feeding schedule.

An older mare, who had previously tried to steal another mare's foal, was introduced to Glynda to no avail. Fortunately, one of our younger mares who had lost her foal to drowning readily "adopted" Glynda. Although this mare's milk had dried up, she watched and protected Glynda in the pasture. Glynda became the friendliest of the 4 Section A fillies foaled this year.

Glynda's biological dam, GlanNant Yellow Brickroad, was able to continue in her riding program and show career without the encumbrance of a foal. Glynda's sire was GlanNant Country Roads, making her line-bred to our wonderful mare, GlanNant Primrose Lane, now deceased.

***editor's note: Unfortunately, GlanNant Glynda later died as a result of an accident that was not related to the Embryo Transplant.*

WPCS STUBBOOKS SELL AT RECORD PRICE!!!

At an auction held by Jones and Llewelyn in Llandeilo, a full set of WPCS studbooks were sold for £5152 (\$10,000 US dollars) to Germany. The studbooks were in the possession of Mrs. Blandy, daughter of H. Meuric Lloyd. Mr. Lloyd was one of the founders of the WPCS and owned the famous stallion, Dyoll Starlight. Volume I of this set was signed by Mr. Lloyd.

Mrs. Blandy had been involved in the famous dispute with Lady Wentworth over the later's sale of Dyoll Starlight to Spain. Mrs. Blandy had maintained that her father had sold Dyoll Starlight, who was then 25 years old, to Lady Wentworth on the condition that he would never be sold and that, when he died, his skeleton would be presented to the British Museum in Mr. Lloyd's name. Other items sold at the auction included books and the contents of the home of Mrs. Blandy, who is now in a nursing home.

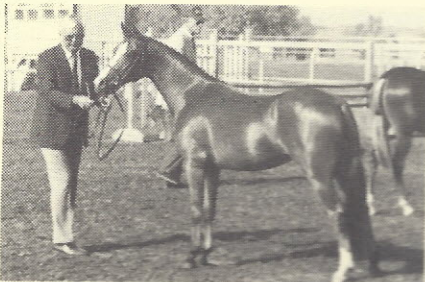

**NEW AWARD CREATED FOR
 PONY RIDERS...**The Oregon
 Dressage Society will present year end
 awards in a new division created for
 pony riders in 1991. The division will
 recognize top riders and their pony
 mounts in junior and senior training
 level.

The decision to add pony awards was
 made at the February meeting
 following a presentation by Kathleen
 Fangsrud of Woodburn, OR. Plans
 were finalized when Oregon's two
 Welsh pony groups, the All Welsh
 Enthusiasts and the Oregon Welsh
 Pony Society, pledged their support
 and willingness to help fund the
 program.

Fangsrud, who competes in senior
 training level on a 13.1hh pony, said
 that she and an increasing number of
 riders and trainers feel there are serious
 riders whose needs are best met by
 ponies, the most obvious being young
 riders. She stated the creation of an
 awards division that recognized smaller
 mounts would encourage dressage
 competition and thus better
 horsemanship among young riders.
 The Welsh Pony & Cob Society of

America and the US Dressage
 Federation currently offer year end
 awards for Welsh Ponies and Cobs, as
 do the local groups; however, to be
 eligible for those awards ponies must
 be registered with the WPCSA.
 The awards system adopted by ODS
 has no registration requirement other
 than current ODS membership. Further
 eligibility requirements for ODS only
 approved show awards are listed in the
 current ODS roster. Awards will be
 based on all scores received at training
 level during the show year. Awards
 will be presented at year end to the
 junior and senior horse/pony rider
 combination receiving the highest
 average score derived from a minimum
 of 3 scores earned at 2 shows under 2
 different judges. Three star shows and
 practice shows will not count toward
 year end awards. All ponies must
 perform AHSA training level tests.
 To apply for year end pony awards,
 ODS members should indicate on the
 rider report form that their is a pony
 and they wish to be considered for this
 award. They should also send a note of
 intent to the awards chairperson
 specifying their mount as a pony before
 their first approved show.

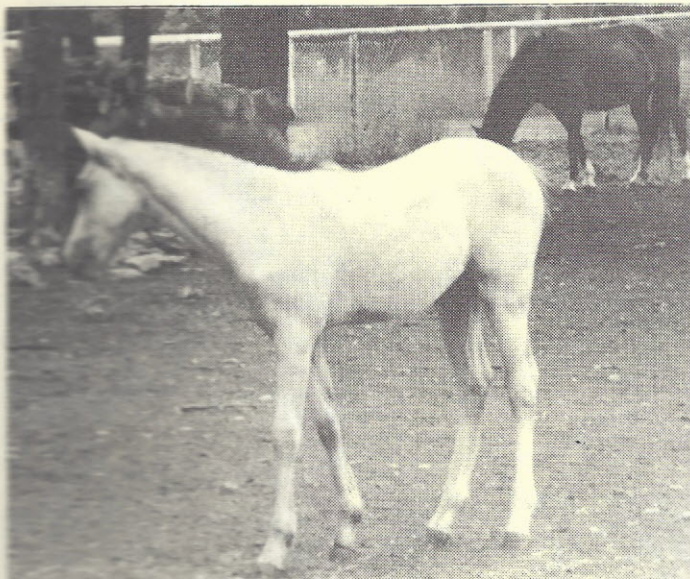

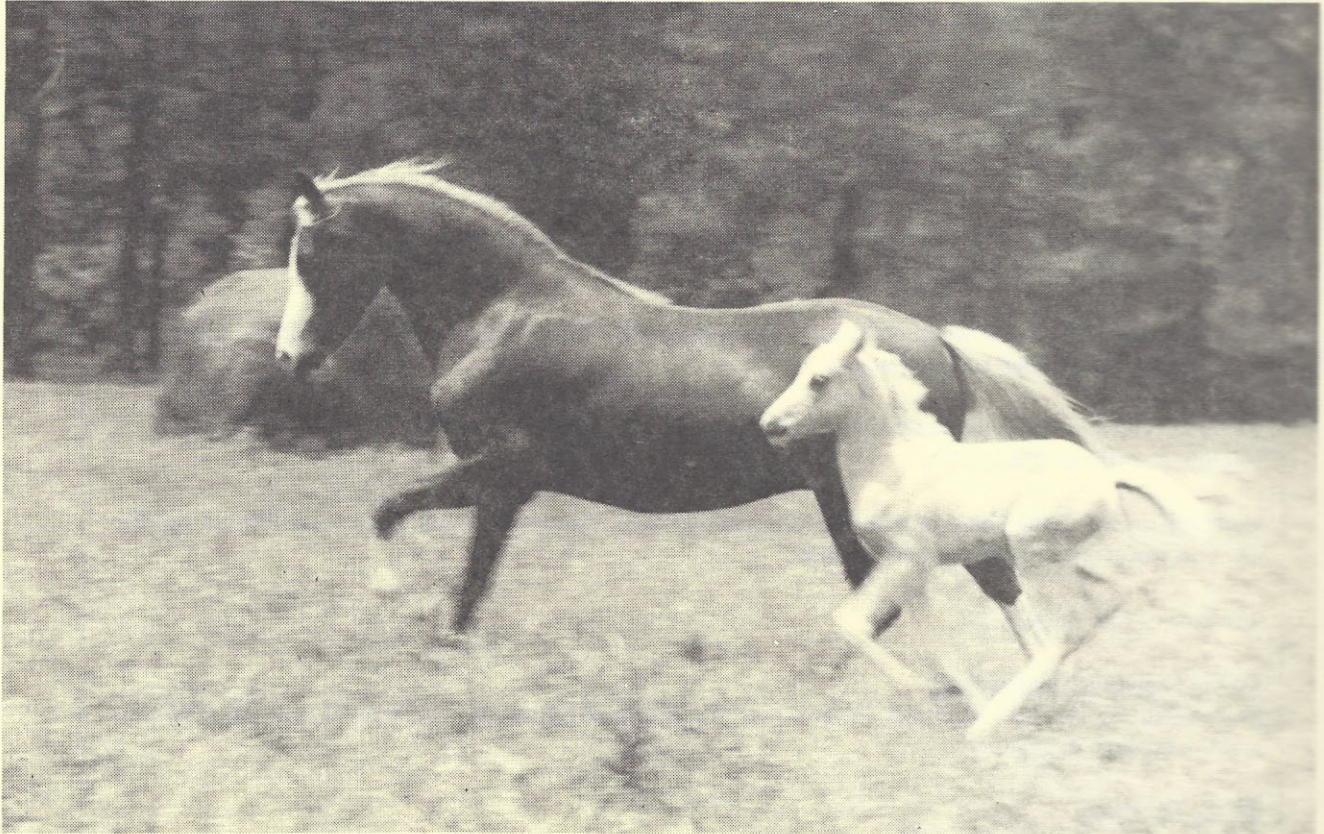

PRESIDENT'S MESSAGE

Dear Members,

The third annual International Conference was held just before the Royal Welsh in Wales. Despite the convenience of time and place, several countries did not attend this year. In fact, there were fewer than 15 non-British delegates in attendance, with Holland, Belgium, Germany, Sweden, Canada, Switzerland and the U.S. represented.

Two subjects were discussed, with some disagreement as to which was the proper one for this group.

1. The EEC Harmonisation
2. Worldwide Harmonisation

Our society need be concerned with the former mainly in that those regulations affect the British Society and; therefore, ponies imported in the future.

Relaxation of the British regulations regarding the acceptance of ponies and cobs bred in other countries into the British stud book will take place for a limited period of time (Jan. 1, 1992 - December 31, 1993). Our Society is asked to produce a list of ponies and cobs properly imported into the U.S. and their descendants with a "gray list" for any questionable animals and a "black" list for any we are sure should not be accepted. Copies of our stud books can be used up to a point and other lists after that. Thereafter, the progeny by or out of these animals would be eligible for registration which is internationally acceptable. This could well prove to be an expensive procedure in terms of clerical work involved. Members should let us know whether they consider the acceptability of our ponies for registration with the Welsh Pony and Cob Society (most importantly...should any ponies or cobs be exported back to Britain) to be a worthwhile goal and how they will be willing to pay for this procedure.

It has come to our attention that the matter of proxy voting is in question. We are presently researching the matter and will inform you when the preliminary research is completed.

By now you should be packing to attend the AGM in Orlando. In response to your request, we have planned 2 days around "input" from members and discussion of various issues by all of us.

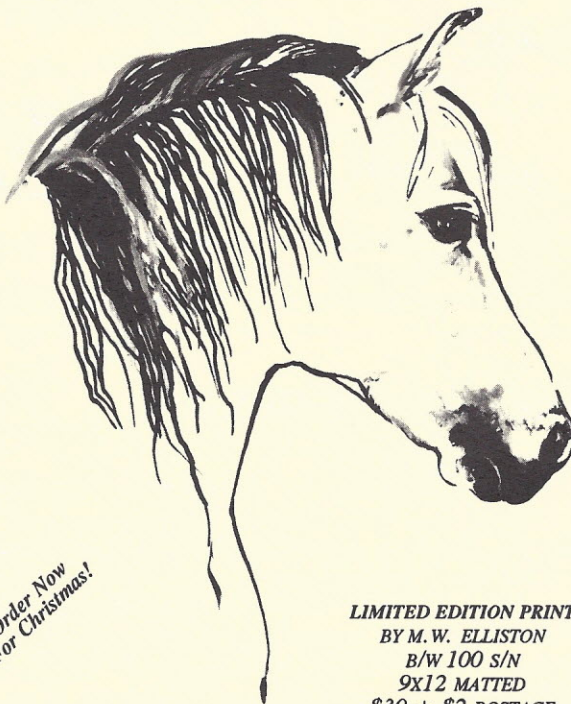

IN COMPARISON

Many members might wonder how the WPCSA fares financially and otherwise in comparison with our neighbors in Australia and the U.K. The following is a report on both these societies.

AUSTRALIA...Dr. Evans and Miss McDonald had represented the Australian Society at the International Conference in Denmark (1990). Dr. Evans had asked that standards for the introduction of A.I. and Embryo Transplant be established as soon as possible as this could be of critical importance to Australia in the short term.

An interesting undertaking of the Australian Society this past year was the survey questionnaire on advertising. The results of this were that members wanted to see their horses promoted as performance. As a result, a call for good quality action photos went out to the members.

The Australian Society will be closing their stud books Appendix for Section C & D FS (foundation stock) animals in 1995. It has been asked if this could be amended to a review rather than closure in 1995. This will be considered; however, Cob breeders at this stage should be prepared for closure.

FINANCIAL REPORT: (in Australian Dollars)

Increases in income were in the sale of promotional goods (up \$8,886), shows and events (up \$24,348), insurance recoveries (up \$3,139) and memberships (up \$4,220). Decreases in income were in advertising and book sales (down \$10,011), registrations (down \$2,780) and interest (down \$3,005).

Increases in expenses were in purchases for resale (up \$3,777), meeting-dinner-fund raising costs (up \$6,284),

salaries (up \$4,577), awards (up \$7,467), typing fees (up \$2,853) and show expenses (up \$19,471). Decreases in expenses were in journal costs (down \$31,963), membership costs (down \$264). All in all the 1990 operating profit was \$8,848 while the 1991 operating profit was \$149.

A large portion of the increase could be attributed to the now mandatory blood-typing of stallions (£8,694). Increases in expenses were attributable to salaries increases of £8,379, postage £6,888, publication and stationary increased £11,156 while awards decreased £18,046.

Computer costs were £10,079 and blood typing costs were £10,126.

The recent drain in reserves has been reversed due to an increase in registration fees, mandatory blood typing of stallions and increased membership fees.

Membership costs in the U.K. are as follows:

Life Member: £500 (\$825 US) under age 21

Life Member: £400 (\$660 US) 21-40 yrs. old

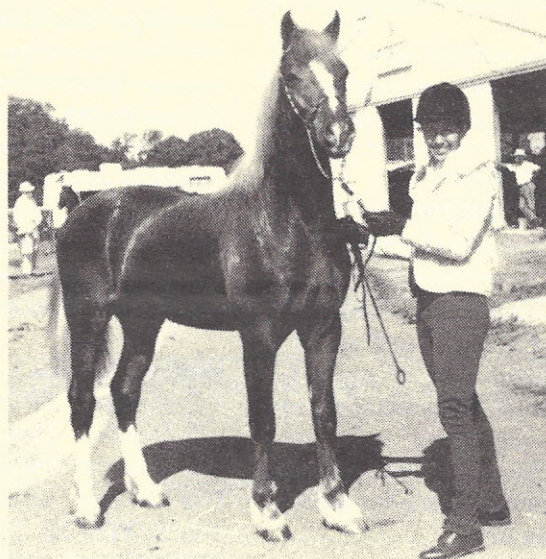

THE HISTORY OF THE WELSH PONY & COB SOCIETY OF AMERICA

(A BRIEF OVERVIEW)

SUBMITTED BY: JANIS SHANEBERGER

I thought it might be fun and interesting for some of our newer members to have a brief view of the history of the Society, its changes and how it has come to be what it is today. Listed below are some of the more interesting highlights:

1906: August 8th - Welsh Pony & Cob Society of America Incorporated, office in Aurora, Illinois. Membership fees were \$25 and members must be approved by the Board of Directors.

Ponies bred and imported from Wales shall not exceed 14hh, and Cobs shall not exceed 15hh. All ponies or cobs bred in Great Britain that have alien blood shall not be registered with the Society.

1915: Responded to appeal from the Canadian Pony Society of Toronto to issue them an honorary certificate of membership.

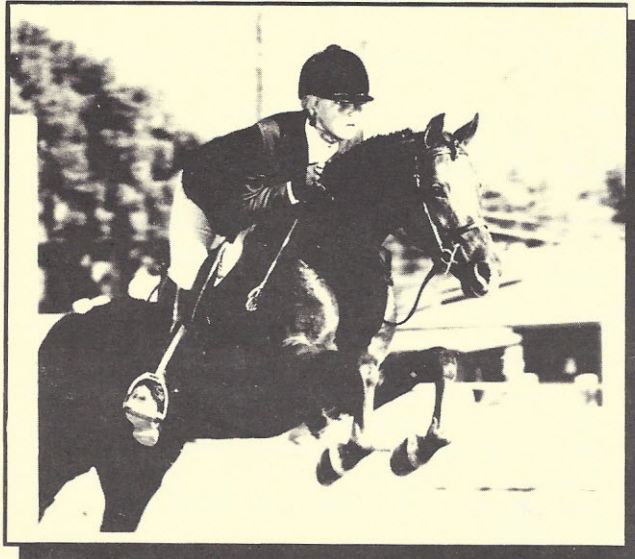

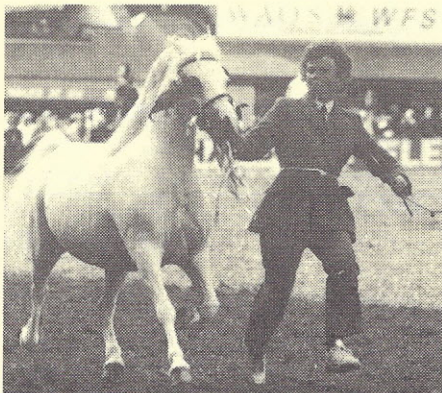

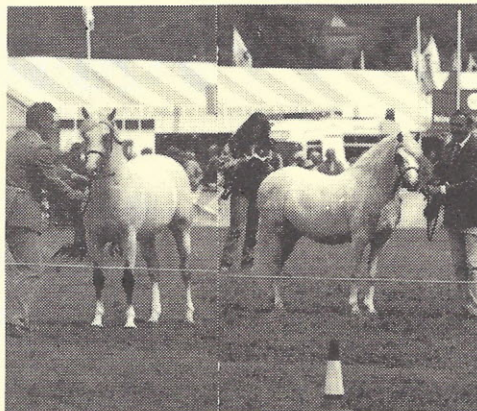

COB STALLION REVOLT AT 1991 ROYAL WELSH

The Royal Welsh was great fun, as always, with huge entries in all Sections. Perhaps one of the most memorable events this year was the decision by the show to excuse half the Cob stallions from the ring after their initial rounds, during which the judge made his tentative placing.

Those stallions not making the "top half" of the class were asked to retire before the individual shows took place. This resulted in some famous (and expensive!) stallions being asked to leave. While it is understandable from management's viewpoint that time must be considered, it is a disappointment for people who have spent a great deal

of time, money and effort to present their stallions at this most prestigious show to be denied the full opportunity to make the world aware of the merits of their animals, regardless of the Judge's first impression. SOOO...a very impressive impromptu show took place during which some of the excused cobs were brought blazing away in front of the stands, at least one for 7 or 8 passes, at the full trot. More than one handler per stallion was required to put on this stunning show and, however much it, no doubt, distressed the management, it added to the fun and thrills for the capacity crowd.

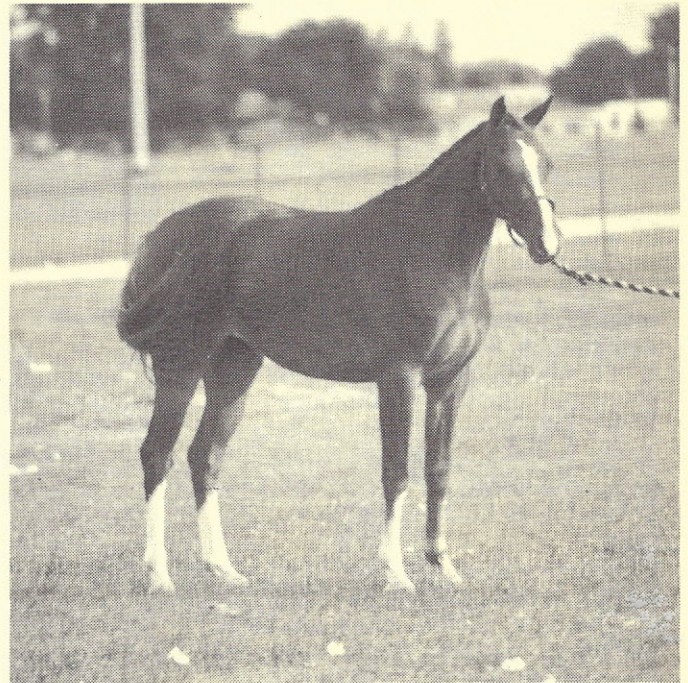

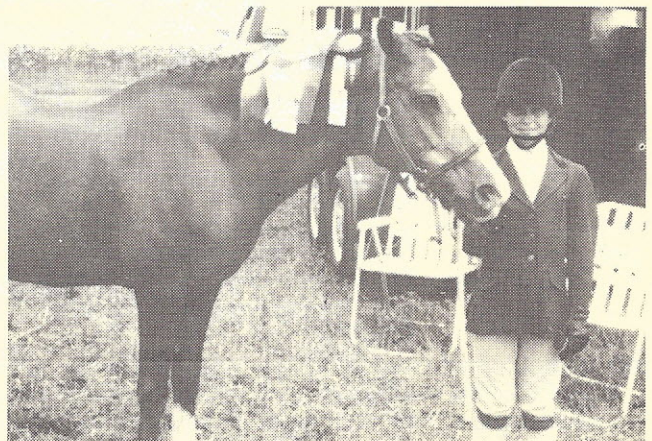

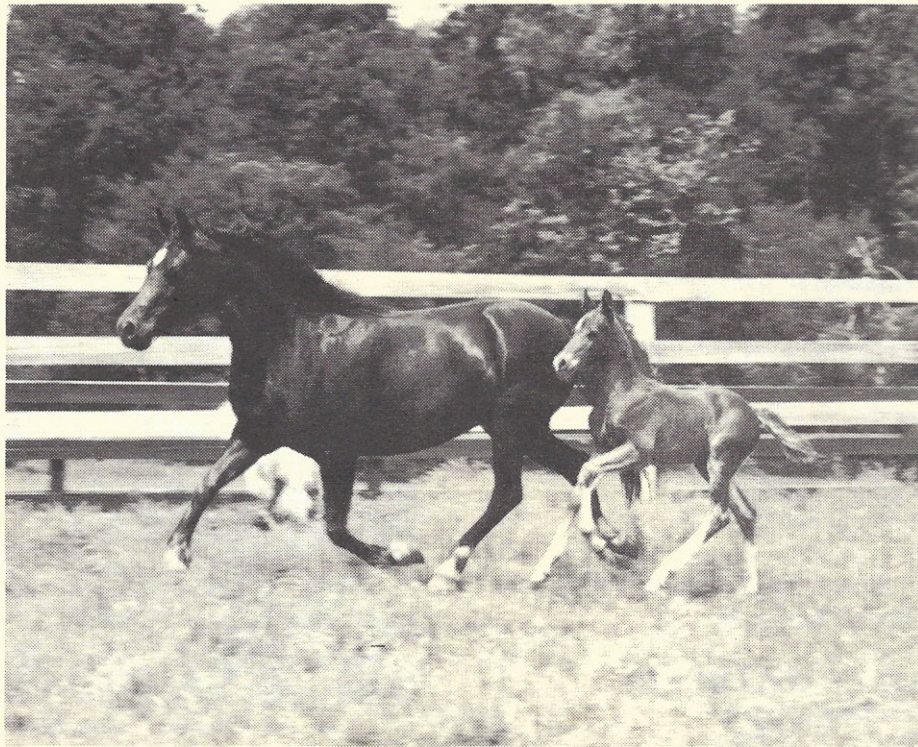

SPORT HORSE OR IS IT SPORT PONY?

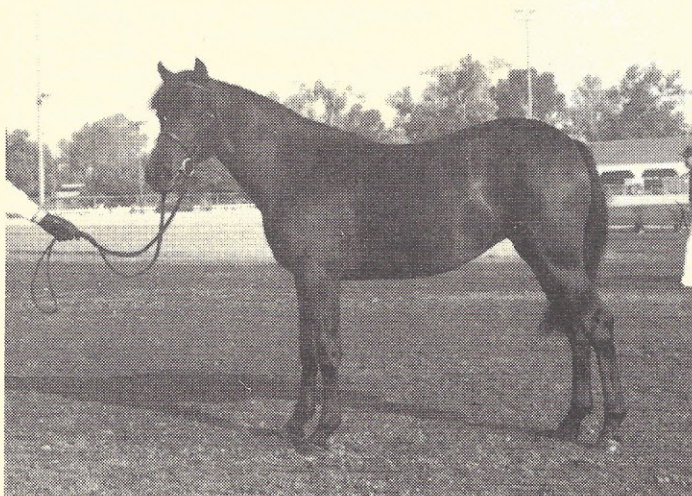
Braving the crowd of Sport Horse Breeders at the 1991 Los Angeles Breeders Classic on Sunday, August 25th, were two audacious pony breeders, Mrs. Janina Owens of Jaycobs Farm and Mrs. Stephanie Abronson of Pony Cross Farm.

They are determined to find a way to show and market their well bred ponies with conformation more like that of the Sport Horse. These ponies are often produced from Welsh and Welsh cob, Connemara, and Quarter ponies, crosses with these basic pony breeds, and with Morgan and Quarter Horses. They are heavier boned and bodied than the traditional Hunter Pony. Yet many of these ponies will cross over into the Hunter Pony Division as mature animals. By attending the L.A. Breeders Classic, they hoped to prove to show manager, Glenda McElroy, their interest and support for a "Sport Pony Division".

Three Welsh Cob crossbred ponies, which are warmbloods every bit as much as Oldenburgs, Hanoverians, Trakhners, etc., were brought to the show. Judge William Solyntjes, from Mankato, Minnesota, admired and encouraged Mrs. Owens and Mrs. Abronson in their endeavor to build interest for a "Sport Pony" division. Admittedly, it was difficult to judge these ponies against the larger warmblood horses; however, Judge Solyntjes comments were that the ponies shown on Sunday were very fine examples of a scaled down version of good sport horses. He anticipates the pleasure of being able to judge the "Sport Pony" Division in the near future.

Following a discussion with Ms. McElroy as to how many breeders and entries she would require to promote a pony division in Sport Horse breeding, she said she would be happy to include such a division in next year's Sport Horse Breeding shows.
