- 1. STALLS WILL NOT BE READY BEFORE TUESDAY AT 10:00 AM.** A limited number of stalls may be available earlier, but you must make prior arrangements by contacting Amy Schwartz at [kelviden@yahoo.com](mailto:kelviden@yahoo.com)
- 2. ANY ENTRIES RECEIVED AFTER SEPTEMBER 20<sup>th</sup>** will be charged a \$200 late fee & will only be accepted if space allows.
- 3. NUMBERS** must be worn and clearly visible whenever mounted/hitched.
- 4. TWO (2) MINUTE GATE RULE: TO BE STRICTLY ENFORCED. ADDITIONAL THREE (3) MINUTES WILL BE ALLOWED FOR A REQUESTED TACK CHANGE. THE GATE WILL NOT BE HELD FOR MORE THAN FIVE (5) MINUTES.**
- 5. Entries** must include a negative coggins (EIA) test dated within 12 months and a Certificate of Veterinary Inspection (CVI) dated within 30 days of the show. Only original or digital forms will be accepted. Foals less than 6 months of age, accompanied by and nursing a negative tested mare are exempt from the testing requirements. Please attach as much paperwork to your entries as possible. Show management will check additional papers before numbers are issued.

**Payment of Fees:** Fees must be paid in full with paperwork and signatures complete before numbers will be issued. An open check must be left with the show secretary in case of any additional adds.

**Class Adds:** Any class added after the early bird discount date will be charged the post entry rate regardless of when the original entry was received. (Please see the chart above). All add/drops on classes must be made through the show office. No gate adds or drops will be accepted.

**Refund Policy:** No refunds will be given unless a class is canceled, or upon presentation of a Vet Certificate/ Doctor's note and notification to the Show Secretary before the start of the show. The Show Management's discretion will be used in other instances. Decisions of Show Management are final.

**Returned Checks:** will be subject to a \$35 fee and must be cleared within 30 days of the last day of the show, or disciplinary actions will be sought through the WPCSA.

**Prize Money:** A total of **\$2,585** is offered. Prize money will be handed out at the show. Classes with less than 3 entries will not pay out prize money.

**Stalls and Bedding:** **STALLS WILL NOT BE READY BEFORE TUESDAY AT 10:00 AM.** A limited number of stalls may be available earlier, but you must make prior arrangements by contacting Amy Schwartz at [kelviden@yahoo.com](mailto:kelviden@yahoo.com). **Shavings may be pre-ordered**, or you may bring your own.. All stalls have doors. **No straw bedding is allowed.**

**Arenas:** The event center is 305' x 125' and the indoor arena is 120' x 240'. Both have sand footing

**Office hours:** Office opens at 7:00 am and will close 30 minutes after the last class is finished each day.

**Championships:** Championships will not be awarded if all classes in that divisions do not have at least 3 entries. The placings in the Conformation Stakes class of each 2-class division will be used in case of ties for championships. In the Hunter Divisions, championship ties will be determined by the pony with the most points over fences and in the carriage driving divisions, they will be determined by a drive off.

**Measurements:** All Welsh, Half-Welsh & Part-Bred animals six years of age and older or any animal showing in any WPCSA performance classes MUST be measured or present valid (current) USEF or WPCSA measurement card. Exception: Animals under 6 years of age who only show in Junior Handler or In Hand Trail need not be measured. **Measurement times will be posted in the show office.** It is the owner's responsibility to make a measurement time before their first class.

**WPCSA Sanctioning:** This is a Welsh Pony and Cob Society of America (WPCSA) Double Platinum Show and USEF Lite Competition and will be conducted in accordance with the rules of the Welsh Pony & Cob Society of America. Each participant in this show is responsible for the knowledge of and is subject to these rules. All WPCSA classes will conform to the class specifications, which can be found at <https://wpcsa.org/compete/class-specs/>

**USEF Sanctioning:** The WPCSA American National Show is rated with the USEF as a Lite Competition. As such, USEF members with properly recorded animals are eligible for USEF Lite points in select recognized divisions. However, this show only offers two classes in all pleasure and pleasure driving divisions and therefore eligible exhibitors will receive points for those two individual classes but will NOT receive USEF championship points in these divisions. USEF Championship points will still be awarded in complete Hunter divisions. Reminder: All USEF Life and Senior Active members, as well as participants who have regular contact with minor athletes, are required to comply with the U.S. Center for SafeSport training requirement to be eligible to participate in the competition. All participants must adhere to the U.S. Center for SafeSport Code, USEF Safe Sport Policy, and the Minor Athlete Abuse Prevention Policies. **Eligibility:** All Ponies/Cobs/Half-Welsh/Part-Breds must be registered with the Welsh Pony and Cob Society of America, Inc., the WPCS, the WPCSC, or, if under one year, be eligible for registration. Only animals registered with the Welsh Pony and Cob Society of America, Inc. will receive points. An animal must be shown under his full registered Welsh number and name. All lease agreements must be officially recorded through the Society office. All recorded leases are designated as such on the animal's Certificate of Registration.

**Management Decisions:** Show management reserves the right to split or combine classes where entries warrant and to make such changes in the class schedule as dictated by the interest of the show. **ANY** abuse towards any animal or Show Official/Staff will be cause for immediate ejection from the show and premises, **WITHOUT REFUND**. Management reserves unto itself the right to refuse or cancel any entries, disqualify riders, drivers or exhibitors without incurring claim for damages. Decisions of the Show Management are final.

**Dogs:** All dogs must be on leash or secured at all times.

**Physical attachment to the facility: including taping, gluing, stapling, nailing, screwing or other means of attachment, is strictly prohibited.** All events will be charged a damage fee for stalls unassembled, removal of panels, the use of screws, etc. **NOTE: Any damage fees incurred by the event will be charged to the responsible exhibitor.**

**Smoking:** is prohibited in all GCFG facilities.

**Driving:** Wire-wheeled vehicles will be allowed. For animals in harness, animals must be fully bridled while hitching and unhitching. **Removing the bridle from an animal harnessed to a vehicle, or leaving an animal unattended while hitched, anywhere on the show grounds, will result in instant elimination and removal from the show grounds.** A properly attired groom or passenger is required for all pairs, tandems, unicorns or 4 in hand, capable of rendering assistance in case of an emergency. Failure to comply will result in elimination from the competition.

**SAFETY EQUIPMENT REGULATIONS: Junior exhibitors must wear approved protective headgear (ASTM/SEI) at all times whenever mounted or in a driven vehicle while on the show grounds. Harness must be secured and properly fitted. Any rider violating this rule at any time must immediately be prohibited from further riding, until such headgear is properly in place. Additionally, Junior Drivers under 14 years of age must always have an experienced adult (over 18) in the carriage.** (An individual who has not reached their 18th birthday as of December 1st of the current competition year is considered a junior). **Adult riders in all classes where jumping is required and when jumping anywhere on the show grounds must wear protective headgear meeting or exceeding (ASTM/SEI) standards for equestrian use, with the harness securely fastened at all times. (Exception: Trail classes) Protective headgear is advised and welcome in all classes of any age group with no judging penalties.**

**USEF rule regarding Junior Exhibitors and motorized vehicles:** Minors who do not have a valid driver's license which allows them to operate a motorized vehicle in the state in which they reside will not be permitted to operate a motorized vehicle of any kind, including, but not limited to, golf carts, motorcycles, scooters, or farm utility vehicles, on the competition grounds of licensed competitions. Minors who have a valid temporary license may operate the above described motorized vehicles as long as they are accompanied by an adult with a valid driver's license. The parent/legal guardian or individual who signs the entry blank as a parent or guardian of a minor operating a motorized vehicle in violation of this rule are solely responsible for any damages, claims, losses or actions resulting from that operation. Violations of this rule will be cause for penalties against those responsible for the child committing the offense. Wheelchairs and other mobility assistance devices for individuals with disabilities are exempt from this rule. The unsafe use of personal electronic transport devices, as determined by the competition officials and management in their sole discretion, that do not require a driver's license to operate, including but not limited to segways, hover boards, and single wheeled scooters is prohibited on competition grounds. Operating such devices in areas where people gather may be deemed "unsafe use" if there is a risk of harm to others. If the operator of the device is a minor, the parent/legal guardian or individual who signs the entry blank as a parent or guardian of a minor operating the device in violation of this rule is accountable and may be subject to penalties. Wheelchairs and other mobility assistance devices for individuals with disabilities are exempt from this rule.
