Show Rules

WPCSA Official Rules and Regulations

All participants showing in WPCSA classes will follow the General Rules and Show Rules for the WPCSA.

1. A negative Coggins certificate or copy dated within one year of the show is required for ALL Horses & Ponies.

2. Payment of Fees: Only cash or check payable in US Currency will be accepted. Fees must be paid in full with paper work and signatures complete **before numbers will be issued**. You can include an open check with your entries or pay the day of the show. Please make checks payable to Valhalla Stables. Returned checks will be subject to a \$25 fee and must be cleared within 30 days of the last day of the show. **Post entry fee is \$25.**

Refund Policy: No refunds will be given unless a class is canceled, or upon presentation of a Vet Certificate/Doctor's note and notification to the Show Secretary before the start of the show. The Show Committee's discretion will be used in other instances. Decisions of Show Management are final.

3. Fees: All classes are \$20. Stakes classes \$40. Halter Class \$20 (per judge). Stalls available for \$125 for the weekend, includes 3 shavings. Grounds Fee (Haul-In): \$30. Additional Shavings \$11/bag, 3 minimum per stall – no outside shavings please. Office fee \$25 and EMT Fee \$15 apply to all entries. WPCSA Non-member Owners \$5 per owner. WPCSA Non-member Measurement Fee \$5 per head. WPCSA Recording Fee \$7 per entry, or \$14 per entry showing halter, with or without performance classes. Jump Fee \$20 for entries competing in over fences classes (includes poles).

4. Exhibitors, parents and/or guardians of minor exhibitors shall indemnify and hold harmless Valhalla Stables, show sponsors, employees and/or all horse show officials and employees or volunteers from any and all liability resulting in injury and/or loss sustained by any person, child or ward of such parent/guardian, in any manner occasioned. Be sure to sign the release of liability attached to your entry form.

5. Ribbons: Ribbons for 1-6th place will be given in all classes. Champion and Reserve Champion in all divisions will receive rosettes.

6. * Prize Money: Prize money will be awarded in all STAKES classes with 3 or more entries. 1st - \$25, 2nd - \$15, 3rd - \$10

7. Driving: For animals in harness, animals must be fully bridled while hitching and unhitching. Removing the bridle from an animal harnessed to a vehicle or leaving an animal unattended while hitched anywhere on the show grounds will result in the instant elimination and removal from the show grounds.

8. All junior riders or any riders competing in any class where jumping is required and/or when jumping anywhere on the show grounds must wear protective headgear meeting or exceeding ASTM/SEI standard for equestrian use. Anyone violating this rule will be prohibited from further riding until in compliance. **NOTE:** Protective headgear is advised and welcome in all classes of any age group, with no judging penalties.

9. NO outside dogs allowed.

10. ANY abuse toward any animal or Show Official/Staff will be cause for immediate ejection from the show and premises, **WITHOUT REFUND.**

11. Management reserves unto itself the right to refuse or cancel any entries, disqualify riders, drivers or exhibitors without incurring claim for damages. Classes will be split where entries warrant. Decisions of the Show Management are final.

12. Two (2) Minute Gate Rule: To be strictly enforced. Additional three (3) minutes will be allowed for requested tack change. The Gate will not be held for more than five (5) minutes.

Measurements: Ponies without a valid measurement form will be measured for competition at 7:00 AM Saturday, June 29th and 7:00 AM Sunday, June 30th. Please note, all ponies competing in performance or halter over the age of six must be measured unless they have a permanent Welsh or USEF measurement card.

MEMBERSHIP

- a) Any person, firm or corporation owning or interested in Welsh ponies or cobs shall be eligible for membership.
- b) There shall be two (2) classes of membership: voting and non-voting.

Voting memberships are defined as follows:
