## Rules and Regulations

Entries are made by exhibitors with the understanding that they are familiar with the following:

1. **ELIGIBILITY:** All Welsh Ponies, Cobs, Half-Welsh and Part-Breds must be registered with the Welsh Pony and Cob Society of America, Inc. (WPCSA), or the Welsh Pony and Cob Society of Canada (WPCSC) or if under one year, must be eligible for registration. Only animals registered with the Welsh Pony and Cob Society of America, Inc. will receive points. An animal must be shown under its full registered Welsh number and name. Before an animal is issued a number or enters the ring, the Show Secretary must have a copy of the Welsh Certificate of Registration in the current owner's name. If the animal is under one year and not yet registered submit a copy of the dam's Certificate of Registration, the registration number and registered name of the sire and the proposed registration name of entry. Unnamed foals may not be shown. A breeding pony may not be shown in both Section A and Section B classes, nor may a cob be shown in both Section C and Section D classes during the same year. All leases are designated as such on animal's Certificate of Registration. Leased animals being shown must present a copy of registration listing the lessee.
2. **ENTRIES:** Hard copy of Pony Registration Papers will NOT be necessary but will be confirmed electronically. If you have a current measurement card with the USEF, please include a copy of it. Exhibitor numbers will be held until ALL paperwork is in order and any measuring has occurred. In addition to payment in full, a signed open check must be deposited with the Show Office.
3. **E-mail (Jen@SilverSprocket.us) entries will be accepted on an official entry form, but at the post entry rate unless a check is mailed to the show secretary and postmarked by the closing date.** Please scan the documents if submitting in this fashion because pictures taken with a phone are illegible.
4. **ALL ENTRIES** are a firm commitment to attend the show. Entries are accepted with the understanding that the Santa Barbara National Horse Show, the 19th DAA and Welsh Pony and Cob Society of America, Inc will not be held responsible for any loss, damage, or injury to any horse exhibited or any article of any kind. All horses shall be under the control and direction of the Horse Show Committee but solely at the risk of the exhibitor, who will be responsible for any loss, damage or injury to any person, animal or property occasioned by him, his agents or employees, or by any animal owned or exhibited by him, and shall indemnify the Santa Barbara National Horse Show, the 19th DAA and WPCSA against any and all loss, damage and liability thus occasioned including but not limited to any and all legal costs, including attorney fees, which may be incurred as a result thereof. The submitting of any entry form shall constitute an acceptance by each person signing same of the provisions herein set forth.
5. **IN ADDITION TO ENTRIES** of persons suspended or expelled from the Federation, the Recognized competition may refuse any entry of an exhibitor or the participation of any agent, trainer, rider, driver or handler who has shown an objectionable attitude towards this Recognized competition or previous unsportsmanlike behavior at a recognized competition or to its management.
6. Every class offered herein is covered by the Rules and Specifications of the current WPCSA Rule Book and will be conducted and judged in accordance.
7. **INCOMPLETE ENTRY FEE.** An entry is incomplete, and a fee will be charged if it does not contain the following:
  - a) Properly signed and, in the case of a minor, signed by a parent or guardian. PLEASE NOTE: The entry form must be signed by all handlers, riders, owners, trainers, and drivers. No one may show a horse unless they have signed the entry form entering that horse. Printed stamps and copies of signatures will not be accepted as a signature.
  - b) Made on an entry form provided by the show.
  - c) Shows correct mailing address of owner.
  - d) Accompanied by payment in full of ALL FEES. e) NO TELEPHONE ENTRIES WILL BE ACCEPTED but stall requests will be noted. Stall fees must be paid prior to show in order to reserve stalls. If groups are to be stalled together, the request must be indicated on the entry form. Every effort will be made to accommodate long-standing, traditional stall locations, but Show Management reserves the right to make assignments to accommodate the general needs with limited stall space. Earl Warren Showgrounds has control over the amount of stall space allotted to the Horse Show.
8. **ENTRIES DUE.** Pre-entries close on **June 19, 2025**. All entries received after closing date, **June 19, 2025**, will be charged a post entry fee of **\$50.00** per pony. Delays in getting the entries to the Show Office will result in delays in getting back numbers and might possibly lead to cancellation of a class due to perceived lack of entries.
9. **POST ENTRIES.** Post entries will be accepted after closing date of June 19, 2025. Entries may be submitted until one hour prior to performance. A \$50 post entry fee will be assessed to entries received after June 19, 2025.
10. **CLASSES WILL BE SPLIT** if entries warrant. This means there must be at least three entries in each split and a Junior or Senior Championship will be awarded in halter. For performances divisions, there will be a division championship for each split and prize money will be included for each stakes class.
11. **THERE WILL BE A PENALTY OF \$50 if a check is refused by the bank for any reason. No checks will be processed through the bank a second time and must be covered by a money order, cashier's check, cash or credit card, in addition to the penalty.**
12. **MEASUREMENT:** All halter animals over 6 years and all performance animals (except animals under six years and only showing in junior handler or In-Hand trail) MUST present a copy of a WPCSA measurement card or a measurement conducted during the current competition year or be measured at the show. Measurement to occur on Wednesday, July 2 between 1-5 PM and on Thursday, July 3, 7-9 AM. Measurement forms available in show office. Halter entries will be measured first. There is no charge for measurement. Owners/lessees who are not members of the WPCSA must pay a \$5 fee per measurement. Animals only exhibiting in Junior Handler and/or In Hand Trail are exempt from measurement.
13. **All ponies must be serviceably sound.** In case of suspected unsoundness, the judge may, if they so desire, have the animal examined by a veterinarian provided by the committee and his/her decision will be final.
14. The rules committee reserves the right to decline any entry and any entry fee and/or stabling fee before or during the show without being liable for compensation.
15. **All attendants** coming in charge of ponies will be subject to the order of the Show Committee and must have their ponies ready to enter the Show Ring at least 15 minutes before the time for showing them.
16. **No person** will be allowed in the Show Ring during the time of judging except the entry or entries and those having duties to perform.
17. **Exhibitors** are notified that **any act of discourtesy or disobedience to the judge or officials**, on the part of the owner, rider, coach or groom, shall disqualify the ponies, and the owner shall forfeit her/his entry fee and other fees.
18. **The Show Committee** reserves to itself the power to prohibit any person from attending or showing a pony in the ring and to remove any groom or pony from the show without being liable for compensation.
19. Should any question or dispute arise that is not provided for in the foregoing rules, the same shall be submitted to the Show Rules Committee whose decision will be final.
20. **JUNIORS ARE NOT PERMITTED TO SHOW STALLIONS**
21. **Removing the bridle from an animal harnessed to a vehicle, or leaving an animal unattended while hitched, anywhere on the show grounds, will result in instant elimination and removal from the show grounds.**
22. **All Juniors in the Welsh division, while riding anywhere on the competition grounds, must wear properly fitting protective headgear which meets or exceeds ASTM (American Society for Testing and Materials)/SEI (Safety Equipment Institute) standards for equestrian use and carries the SEI tag. Harness must be secured and properly fitted. Any rider violating this rule at any time must immediately be prohibited from further riding until such headgear is properly in place.**

23. **A Junior exhibitor** is an individual who has not reached his/her 18th birthday as of December 1st of the current competition year. The age of an individual on December 1st will be retained throughout the entire competition year. Persons born on December 1st assume the greater age on that date.
24. **An Adult exhibitor** is an individual who has reached his/her 18th birthday as of December 1st of the current competition year.
25. **DIVISION CHAMPIONSHIPS:** In case of a tie in a two-class division, the championship or reserve will be awarded to the animal that accumulated the most points in the Conformation Stake class. In the hunter divisions, the Championship or Reserve will be awarded to the animal that scores the highest in the over fence classes. Ties in all other divisions will be settled by the flip of a coin.
26. **Food/Refreshment.** Food and beverage will be available on Showgrounds during horse show hours.
27. **Dining.** Santa Barbara is rich in hospitality and dining. Numerous choices available for all culinary tastes. Check-out <http://www.santabarbara.com>
28. **Dogs** on the show ground **MUST** be kept on a leash or in a crate.
29. **Entering the ring without doing entry/add/drop through the show office,** causes major delays. Please be considerate of staff and fellow exhibitors to keep the show moving. A convenience fee of \$10 will be assessed per class if added at the gate or anywhere other than the show office. Drops anywhere other than the show office or done after the class has begun will be assessed a \$10 convenience fee and the entry fee will **NOT** be refunded.
30. **Wire-wheeled vehicles** are permitted in all driving classes.
31. **The Judges' Decisions are final.**
32. **ALL owners and exhibitors** will be held responsible for any damage or alterations incurred by them or their agents to barns or other Earl Warren Showground properties. IT IS STRICTLY FORBIDDEN TO REMOVE STALL DOORS. VIOLATORS WILL BE FINED ACCORDINGLY. MINIMUM \$200 PER STALL.
33. **THE SANTA BARBARA NATIONAL HORSE SHOW** reserves the right to cancel or combine classes in which there are insufficient entries and the specifications will allow.
34. **THE HORSE SHOW COMMITTEE** reserves the privilege of substituting or changing judges if it becomes necessary. The Judges' decisions in the show ring are their own responsibility and the Show Committee accepts no responsibility for these decisions.
35. **REFUNDS.** Full refunds will be given if written notice is received by the Show Secretary before June 30, 2025. Exhibitors scratching a horse for any reason after that date shall forfeit all entry, stall and association fees, **UNLESS** a valid Veterinarian's or Doctor's certificate of disability for entered horse/rider is submitted to the Horse Show Secretary **PRIOR** to the first event of the horse show, in which case a \$30 fee will be assessed. If illness or injury after the start of the show should prevent exhibitor's participation in the balance of entered classes, a refund of un-used class fees will be made, less a \$30 fee, providing the balance of classes are officially scratched and a doctor's certificate is provided within 48 hours of the close of the show. Stall and association fees will not be refunded.
36. **The Judges and the Show Committee may intercede in any situation that appears to be unsafe to exhibitors, ponies and bystanders to reduce the possibility of accident or injury.**
37. **MOTORIZED VEHICLES** - Minors who do not have a valid driver's license which allows them to operate a motorized vehicle in the state in which they reside will not be permitted to operate a motorized vehicle of any kind, including, but not limited to, golf carts, motorcycles, scooters, or farm utility vehicles, on the competition grounds of licensed competitions. Minors who have a valid temporary license may operate the above described motorized vehicles as long as they are accompanied by an adult with a valid driver's license. The parent(s), legal guardian(s), or individual who signs the entry blank as a parent or guardian of a minor operating a motorized vehicle in violation of this rule are solely responsible for any damages, claims, losses or actions resulting from that operation. Violations of this rule will be cause for sanctions against the parent(s), guardian(s) and/or trainer(s) who are responsible for the child committing the offense. Penalties may include exclusion of the child, parent(s), guardian(s), and/or trainer(s) from the competition grounds for the remainder of the competition and charges being filed against any of the above individuals in accordance with Chapter 6. Wheelchairs and other mobility assistance devices for individuals with disabilities are exempt from this rule. Golf carts and bicycles will be allowed only in the STABLE AREA. Golf cart drivers must be at least 18 years of age.
38. **PRIZE MONEY** - There will be a payback of \$30 for 1st place and \$20 for 2nd place. All classes must have 3 or more entries shown and judged for monies to be paid. Payback will be mailed within 30 days after the closing of the show. Payback will be awarded to all Stake classes.
39. **RV & CAMPER** reservations can only be made via the Earl Warren Showgrounds website: [www.earlwarren.com/rv-park/](http://www.earlwarren.com/rv-park/) | **NO RV SPACES MAY BE RESERVED THROUGH THE HORSE SHOW OFFICE.**
40. **STALLS.** Stalls are **10' X 10' wood**, with Dutch doors. Exhibitor is responsible for all damage and alterations to the facility. It is strictly forbidden to remove stall doors. Violators will be fined a minimum of \$200 per stall.
41. **FOOTING** in all arenas is a combination of dirt, sand and organic material. Arenas are approximately 125' X 250'.
42. **PARKING.** Fire regulations prohibit exhibitor vehicles including cars, trailers, vans and campers from being parked in barn areas. Designated parking will be posted. There will be no exceptions and violators will be towed away at owner's expense.
43. **STABLING:** Stalls will be available Tuesday, July 2, 7:00 AM. All stalls must be vacated Saturday, July 6. Stalls are 10' X 10' wood, with Dutch doors. Exhibitor is responsible for all damage and alterations to the facility. It is strictly forbidden to remove stall doors. Violators will be fined a minimum of \$200 per stall.
44. **EARLY ARRIVAL:** Anyone arriving earlier than 7:00 AM, Tuesday, July 2, 2025, **MUST** contact the Show Manager to make arrangements. Early arrivals will be required to pay a fee of \$35 per day per STALL.
45. **ALL STALL RESERVATIONS MUST BE PHONED OR TEXTED TO LANCE BENNETT 760-525-8933**
46. **ALL FEED AND BEDDING ORDERS MUST BE PHONED OR TEXTED TO LANCE BENNETT 760-525-8933**

## MEMBERSHIP

Any person, firm or corporation owning or interested in Welsh ponies or cobs shall be eligible for membership. There shall be two (2) classes of membership: voting and non-voting.

### **Voting memberships are defined as follows:**

1. Senior Life Membership – those persons who have reached their 18th birthday by January 1st of the current year.
2. Annual Membership – those persons who have reached their 18th birthday by January 1st of the current year.
3. Family/Firm – immediate family unit - parent/guardian and minor children (who have not reached their 18th birthday) or a corporation/firm or association. The Family/Firm unit will be entitled to only one vote.

### **Non-Voting Memberships shall be defined as follows:**

5. Annual Associates - those persons who have reached their 18th birthday by January 1st of the current year & who are interested in the breed but do not desire full membership privileges. No reduction of transfer & registration fees.
6. Junior Membership - those persons who have not reached their 18th birthday by January 1st of the current year.
