Welsh and Half-Welsh/Part-Bred - Section A, B, C and D

1. All entries must be registered in the stud book of the Welsh Pony Society of America, Inc. or the Welsh Section of the Canadian Pony Society and must be entered under their full registered name, or if under one year, be eligible for registration.
2. All halter ponies **age 6 and over and all performance ponies** must either have a WPCSA permanent measurement card, two WPCSA temporary cards, an USEF measurement card or be measured. Animals only exhibiting in Junior Handler and/or In-Hand Trail are exempt from measurement. **Measurement Time** - August 28, 2025 between 8:30 a.m. and 9:00 a.m. **Non-Member Measurement Fee - \$5.00 per pony.**
3. A photocopy of the WPCSA Certificate of Registration in the current owner's name must be presented before the animal can be assigned a number or enter the ring.
4. **Removing the bridle from an animal harnessed to a vehicle, or leaving an animal unattended while hitched, anywhere on the show grounds, will result in instant elimination from the show grounds.**
5. **Junior exhibitors must wear approved protective headgear (ASTM/SEI) at all times whenever mounted or in a driven vehicle at all times while on the show grounds. Harness must be secure and properly fitted. Any rider violating this rule at any time must immediately be prohibited from further riding until such headgear is properly in place.**
6. This show has applied for a Provisional WPCSA Gold Show by the Welsh Pony and Cob Society of America. All ponies shown in the halter classes will pay \$7.00 per pony per judge and if not shown in Halter, but Performance only the fee will be \$7.00.
7. At the discretion of the Superintendent, classes may be combined, divided or canceled.
8. Permanent stalls with doors and straw bedding are provided free of charge and are available on a first come first serve basis.
9. Entry fee is \$10.00 per class unless otherwise stated.
10. No bedding material other than straw may be used. Exhibitors must clean out their stalls and place the manure in designated areas.
11. All animals over nine months of age must have a certificate indicating a Negative Coggins Test made within 12 months prior to show date. Photocopy stamped by the appropriate animal health official of the respective State will be accepted in lieu of the original certificate.
12. Foals may accompany their dams in the ring but must be led.
13. Animals entered in group classes must be entered in an individual class.
14. Entries will be accepted on a first come first taken basis and may be limited to available stall space.
15. No refunds will be given after closing date of pre-entries.
16. Veterinarian and Farrier will be available on the fairgrounds.
17. Every pony entered for competition will comply with the rules of the horse show management, but management will, in no case, be responsible for any loss or damage that may occur, and it shall be condition of entry that each exhibitor shall hold this horse show, the Maryland State Fair Welsh Pony Show, its directors, employees and the officials blameless for any loss or accident to his pony, employee, equipment, which may occur from sickness, fire, or otherwise.

Maryland State Fair Food Court will be Open to the Public during the Fair.

Contact Information will be Posted at the Show Office and in the Stable Area for the Veterinarian and Farrier.

MEMBERSHIP

- a) Any person, firm or corporation owning or interested in Welsh ponies or cobs shall be eligible for membership.
- b) There shall be two (2) classes of membership: voting and non-voting.

Voting memberships are defined as follows:

1. Senior Life Membership – those persons who have reached their 18th birthday by January 1st of the current year.
2. Annual Membership – those persons who have reached their 18th birthday by January 1st of the current year.
3. Family/Firm – immediate family unit - parent/guardian and minor children (who have not reached their 18th birthday) or a corporation/firm or association. The Family/Firm unit will be entitled to only one vote.

Non-Voting Memberships shall be defined as follows:

4. Junior Life Membership – those persons who have not reached their 18th birthday by January 1st of the current year. Upon reaching 18, the membership will become Senior Life.
5. Annual Associates - those persons who have reached their 18th birthday by January 1st of the current year & who are interested in the breed but do not desire full membership privileges. No reduction of transfer & registration fees.
6. Junior Membership - those persons who have not reached their 18th birthday by January 1st of the current year.

Privileges WPCSA Members: Reduced registration and transfer fees (with the exception of Annual Associate members); Right to compete for High Score Awards; Subscription to quarterly WPCSA Welsh Review Newsletter. All new members receive a complimentary literature packet and decal.

Note: Your dues or contribution to the association are not deductible as charitable contributions. Please consult with your tax advisor to determine whether they may be deducted under other provisions of the law (such as the provisions relating to the deductibility of business expenses).
