

Admission to Show: Free

Refunds: None

Returned Check Policy: If a check is returned unpaid, the show will assess a \$25.00 fee and a money order, cashiers check or cash must be presented to show management. No premiums will be paid until all delinquent funds are collected.

Office hours: Noon to 7:00 pm on Friday. 7:00 am to close of show on Saturday and Sunday.

Show Check-in Requirements: All equine will be accompanied with a record of a negative official test for EIA (Coggins) conducted within the past 12 months. You must present the <u>original form</u> and <u>not a copy</u> upon arrival. Foals less than 6 months of age, accompanied by and nursing a negative tested mare are exempt from the testing requirements. This is a state law and show management will check papers when you arrive and if proper documentation is not present, you will not be permitted to remain on the grounds.

Measurements: All Welsh, Half-Welsh and Part-Bred animals six years of age and older, or any animal showing in any WPCSA performance classes, MUST be measured or present valid (current) USEF or WPCSA measurement card. Exception: Animals under 6 years of age who only show in Junior Handler or In-Hand Trail need not be measured. Measurement times will be posted in the show office. It is the owner's responsibility to make a measurement time before their first class.

Stalls and Bedding: Arrangements for access to stalls prior to 8:00 am Friday must make arrangements with Denise Dougherty (cell phone: 580-402-6558) to get into the stalls. No outside bedding.

Prize Monies: Total monies offered is \$480 (Show #1 \$240, Show #2 \$240)

Awards: Ribbons 1st-5th place. Rosettes for performance and halter Champion and Reserve and Grand Champion and Reserve and Supreme Champion and Reserve Supreme Champion. Any divisions that are not filled (3 entries in all classes in division) will not be awarded Championships.

4 · Rules & Regulations

Sanctioning: This is two Provisional Welsh Pony and Cob Society of America (WPCSA) Back-to-back Double Silver Shows. All WPCSA classes will conform to the class specifications, which are included herein. Welsh performance championships are based on points only, no entry fees are required for those classes. To qualify for entry in Stake classes, the exhibitor must enter and compete in at least one other class in the division.

Classes: Show management reserves the right, with permission of the exhibitors, to cancel classes that have no entries, or to divide the classes in which the entries cannot be accommodated in the ring at one time, and to make such changes in the class schedule as dictated by the interest of the show. If there are 8 or more 12.2 and under and 8 or more over 12.2 to 14.2 hand ponies in any WPCSA class, it will be split. Classes are open to stallions, mares and geldings. WPCSA classes of less than three entries will receive reduced points and will not be combined.

Motels near facility: There are several nearby options in Denton.

Feed/Supplies: are available at D & L Farm & Home in Aubrey. 7976 US 377.

Food: There will be concessions on the grounds. Many other options in Denton and surrounding area.

R.V. Hook-ups: RV hook-ups are available at \$50/night. Spots are limited. Contact show secretary for reservation.

Dogs: Dogs are allowed but must be on leash attached to someone/something at all times.

This show is conducted in accordance with the rules of the Welsh Pony & Cob Society of America. Each participant in this show is responsible for the knowledge of and is subject to these rules.

SHOW RULES AND REGULATIONS In addition to the General Rules of the WPCSA

Attire: Riders must be properly attired according to the rules of the division in which they are competing. Riders in all classes where jumping is required, and when jumping elsewhere on the show grounds, must wear protective headgear. Numbers must be worn and be clearly visible.

Adult Exhibitors: An individual who has reached their 18th birthday as of December 1st of the current competition year.

Junior Exhibitors: An individual who has not reached their 18th birthday as of December 1st of the current competition year. When dividing junior divisions into two separate age groups, they will be split as follows: youth 12 & under and youth 13 and over (but have not reached their 18th birthday by December 1st of the current competition year. Juniors under 14 years of age cannot show a stallion. Junior exhibitors must wear approved protective headgear (ASTM/SEI) at all times whenever mounted or in a driven vehicle at all times while on the show ground. Harness must be secured and properly fitted. Any rider violating this rule at any time must immediately be prohibited from further riding until such headgear is properly in place.



MEMBERSHIP

- a) Any person, firm, or corporation owning or interested in Welsh ponies or cobs shall be eligible for membership.
- b) There shall be two (2) classes of membership: voting and non-voting.

Voting memberships are defined as follows:

- 1. Senior Life Membership those persons who have reached their 18th birthday by January 1 of the current year.
- 2. Annual Membership those persons who have reached their 18th birthday by January 1 of the current year.
- 3. Family/Firm immediate family unit parent/guardian and minor children (who have not reached their 18th birthday) or a corporation, firm or association. The Family/Firm unit will be entitled to only one vote.

Non-Voting Memberships shall be defined as follows:

- 4. Junior Life Membership those persons who have not reached their 18th birthday by January 1 of the current year. Upon reaching 18, the membership will become Senior Life.
- 5. Annual Associates those persons who have reached their 18th birthday by January 1 of the current year and who are interested in the breed but do not desire full membership privileges. No reduction of transfer and registration fees.
- 6. Junior Membership those persons who have not reached their 18th birthday by January 1 of the current year.

Privileges WPCSA Members receive: Reduces registration and transfer fees (with the exception of Annual Associate members); Privilege of appearing in the Member/Breeder Directory (with the exception of Junior and Annual Associate members); Right to compete for High Score Awards; subscription to quarterly WPCSA Welsh Review Newsletter. All new members receive a complimentary literature packet. New life members receive a complimentary pin; new Annual, Family/Firm and Annual Associate members receive a complimentary 3" decal; new Junior members receive a complimentary poster.
